This letter is in response to the meeting held 10 June 2010 regarding a draft MS4 permit for Joint Base Lewis McChord (JBLM). During the meeting, EPA representatives requested additional information.

The original notice of intent was submitted in March 2003 for Fort Lewis, Washington. In February 2010, Fort Lewis and McChord Air Force Base merged and was designated Joint Base Lewis-McChord, a single installation. In response to this merger JBLM is submitting a revised NOI listing JBLM as the permit holder. The following page is the revised NOI reflecting this change.


