

ORDER ON POST-ARGUMENT BRIEFING

On October 1, 2015, the Board held oral argument in this proceeding. The purpose of such briefs shall be to respond to questions raised by the Board at the oral argument. These briefs may not raise new arguments or be based on new affidavits or declarations.

If the U.S. Environmental Protection Agency, Region 5, decides to file a brief, the Region's brief shall reflect the views of EPA's Office of General Counsel and Office of Solid Waste and Emergency Response.
