#### **SCHEDULING ORDER**

On November 3, 2020, Mr. Dave Erlanson, Sr. filed an appeal with the Environmental Appeals Board ("Board") in the above-captioned matter. On November 20, 2020, the Board issued an Order directing Mr. Erlanson to show cause as to why his appeal should not be dismissed for failure to comply with the requirements of 40 C.F.R. § 22.30(a)(1). Order Vacating Decision to Decline Sua Sponte Review, Docketing Appeal, and Order to Show Cause (Nov. 20, 2020). The Board received Mr. Erlanson's response on November 30, 2020 and the U.S. Environmental Protection Agency ("U.S. EPA") Region 10's ("Region 10") reply on December 11, 2020.

In addition to the response to show cause, the Board has received Mr. Erlanson's appellate brief and brief challenging the jurisdiction of the U.S. EPA.
