

**ORDER CONSOLIDATING PETITIONS FOR REVIEW
AND EXTENDING TIME TO FILE RESPONSE**

On March 19, 2014, the U.S. Environmental Protection Agency Region 3 (“Region”) issued an Underground Injection Control (“UIC”) permit, Number PAS2D013BIND (“Permit”), to Pennsylvania General Electric Company for a Class II injection well. The Environmental Appeals Board (“Board”) received a petition for review of the Permit from each of the following: 1) Suzanne Watkins (UIC Appeal No. 14-63); 2) Judy and Paul Wanchisn and Stacy and Mark Long (UIC Appeal No. 14-64); and 3) William J. Woodcock III (UIC Appeal No. 14-65). On April 25, 2014, the Region moved to consolidate all petitions for review of the Permit and sought leave to file one consolidated response. In addition, the Region seeks an extension of time to file a consolidated reply until May 15, 2014. *See* Region III’s Motion to Consolidate Appeals, for Leave to File a Consolidated Response, and for an Extension of Time to File Responses to Watkins and [Wanchisn]/Long Petitions; Correction to Region III’s Motion to Consolidate Appeals, for Leave to File a Consolidated Response, and for an Extension of Time to File Responses to Watkins and Wanchisn/Long Petitions.

For administrative convenience and in the interest of efficiency, the Board hereby consolidates the petitions for review of the Permit and grants the Region's request to submit a single response to the three petitions filed. The Region's consolidated response to the three petitions is due on **May 15, 2014**.
