Enclosed is the NPDES permit, ND-0030988, for the Mandan, Hidatsa, and Arikara Nation Clean Fuels Refinery. The NPDES permit shall become effective October 1, 2011, unless, within thirty (30) days following the date of the Federal Register Notice of Availability of the Record Of Decision to issue the NPDES permit, a petition is received by the Environmental Appeals Board to review any condition of the permit pursuant to the provisions of 40 CFR §124.19. If you decide to file a petition for review with the EAB, the petition must contain all information required by 40 CFR §124.19(a). 
