APPEAL TO THE HEARING BOARD OF THE NORTH COAST UNIFIED AIR QUALITY MANAGEMENT DISTRICT

In the matter of the "Appeal" by Rob Simpson re Pacific Gas & Electric Company (ATC Permit No. 443-1)

) ORDER DENYING REQUEST
) FOR PUBLIC HEARING
) (Health and Safety Code section 42302.1)

On October 27, 2008 the Hearing Board of North Coast Unified Air Quality Management District received from the North Coast Unified Air Quality Management District an e-mail from Rob Simpson, 27126 Grandview Avenue, Hayward, CA 94542 (hereinafter referred to as "Petitioner") captioned as "Appeal before North Coast Unified Air Quality Management District Hearing Board". The e-mail included a website link to Petitioner's Petition for Review in proceedings before the U.S. Environmental Protection Agency, Environmental Appeals Board, Appeal No. PSD 08-08, Re Humboldt Bay Repower Project.

The Petitioner's e-mail to the North Coast Unified Air Quality Management District states: "Please consider this communication and the linked proceedings as my appeal to the hearing Board [sic]."

The Petitioner's Petition for Review before the U.S. Environmental Protection Agency, Environmental Appeals Board appears to relate to the North Coast Unified Air Quality Management District permit to Pacific Gas & Electric Company, ATC Permit No. 443-1, issued April 14, 2008. As such, the Hearing Board shall consider the Petitioner's e-mail dated October 22, 2008 to constitute a "Request of Public Hearing to Contest Issuance of Permit" within the meaning of Health and Safety Code section 42302.1.

Health and Safety Code section 42302.1 provides in pertinent part as follows: "Within 30 days of any decision or action pertaining to the issuance of a permit by a district, ... any aggrieved person who, in person or through a representative, appeared, submitted written testimony, or otherwise participated in the action before the district may request the hearing board of the district to hold a public hearing to determine whether the permit was properly issued. ..."

FINDINGS

- 1. The Petitioner's e-mail of October 22, 2008 was received more than 30 days after the North Coast Unified Air Quality Management District issued ATC Permit No. 433-1 on April 14, 2008;
- 2. Records of the North Coast Unified Air Quality Management District have no indication that Petitioner "in person or through a representative, appeared, submitted written testimony, or otherwise participated in the action before the district" relating to the issuance of ATC Permit No. 433-1.

ORDER

Based upon the above findings and good cause being found, Petitioner's e-mail of October 22, 2008 is found to not constitute a valid request for public hearing pursuant to Health and Safety Code section 42302.1, on the basis that is not timely, and further on the independent ground that Petitioner does not meet the requirements of participation in the underlying proceedings of the North Coast Unified Air Quality Management District to qualify for standing to request a public hearing pursuant to Health and Safety Code section 42302.1. Therefore, the request for public hearing is DENIED.

Rob, thanks for the information. I checked around and as I relayed to you yesterday there does not exist a process for appealing district permits with the ARB. It is clear under State law that local districts have authority for issuing permits to stationary sources. Any appeal of a permit would be through the local district. The only exceptions are with PSD and Title V permits that can under some circumstances be appealed through U.S. EPA. In addition, for power plants licensed through the Energy Commission there may be a process with them but would defer to them to answer the question. Let me know if I can be of further assistance.
