### MOTION OF PETITIONER TO RECONSIDER AND FOR LEAVE TO EXTEND TIME TO FILE REPLY

Petitioner, Sierra Club, respectfully moves the Environmental Appeals Board to reconsider its October 10, 2008 Order in this case and for leave to allow Petitioner's untimely reply to the Response of the Northern Michigan University.<sup>1</sup>

On September 8, 2008, the Board issued an Order allowing Northern Michigan University to intervene and allowing it to file a Response to the Petition by September 22, 2008. The Order also provided that Petitioner, Sierra Club, may file a reply to Northern Michigan on October 1, 2008. The undersigned counsel for Sierra Club misread the Order as establishing the deadline for reply as October 7<sup>th</sup> and calendared that date for a response.

Petitioner filed its reply on October 3<sup>rd</sup>, 2008, mistakenly believing it to be filed *ahead* of the Board's deadline. Today, October 10, 2008, the Board entered an Order correctly noting that Petitioner's reply to Northern Michigan University's brief was not accompanied by an explanation or acknowledgement of the reply's untimeliness, and with no timely efforts to seek modification of the filing date. Petitioner's reply filing contained no explanation or acknowledgement of untimeliness because counsel had not realized, at the time of its filing, that the reply was not timely. Receipt of today's Order was counsel's first indication of his mistake regarding the deadline to reply. This motion followed immediately.

The undersigned counsel apologizes for his mistake and Petitioner respectfully requests that the Board reconsider its Order and allow Petitioner to file its reply out of time. The basis for this motion seeking to file a reply out of time is counsel's inadvertence and mistake.
