Dear Mr. Heitzman:

The above-referenced National Pollutant Discharge Elimination System (NPDES) permits (Permits) were issued on August 8, 2024. On September 10, 2024, the U.S. Environmental Protection Agency Region 10 (Region 10) received notification from the Environmental Appeals Board (EAB) that Northwest Environmental Advocates (NWEA) had filed a petition for review of the above-mentioned Permits (Appeal No. NPDES 24-03).

After reviewing the petition for review, Region 10 has determined that none of the conditions of the Permits should be stayed. NWEA's petition for review does not appear to contest a specific condition of the Permits. Instead, the petition for review challenges the absence of a condition that NWEA requested Region 10 add to the Permits during the public comment period. Since all of the Permits' conditions will have to be met regardless of the outcome of NWEA's appeal, both Permits' conditions are uncontested within the meaning of 40 C.F.R. § 124.60(b)(6)(ii). As such, in accordance with 40 C.F.R. § 124.16(a)(2), the entirety of both Permits will become fully effective and enforceable on January 1, 2025, as set forth in the Permits.
