

Re: Notice of Contested and Uncontested Conditions of NPDES Permit No. MA0100986 Fitchburg East Wastewater Treatment Facility NPDES Appeal No. 10-14

Dear Ms. Durr, Mr. Jordan, and Mr. Evans:

On August 26, 2010 the City of Fitchburg (Massachusetts) Wastewater Treatment Facilities Commission ("Permittee") filed a Petition for Review ("Petition") of NPDES Permit No. MA0100986 ("Permit") with the Environmental Appeals Board ("Board") pursuant to 40 C.F.R. § 124.19(a). The Permit had been reissued to the Permittee on July 22, 2010 by the New England Regional Office of the U.S. Environmental Protection Agency ("Region"). The Permit superseded the permit issued by the Region on September 13, 2002 ("Prior Permit").

In its Petition, the Permittee contests the following limitations and conditions of the Permit:

1. The seasonal (April 1-October 31)¹ total phosphorus concentration-based limit of 0.2 mg/l, found in Part I.A.1 of the Permit, at page 3; and

¹ The Permit's challenged seasonal phosphorus limits extend from April 1-October 31. However, the Petition states only that it is challenging the phosphorus limits applicable during the period April 1-October 1. For the limited purpose of this notice of contested and uncontested conditions, and without waiving any available arguments in response to the Petition, the Region deems the seasonal phosphorus limits to be stayed for the period October 2-31 as well.

2. The seasonal (April 1-October 31) total phosphorus mass-based limit of 20.7 lb/day, found in Part I.A.1 of the Permit, at page 3.

The limitations and conditions contested by the permittee are collectively referred to herein as the "Contested Conditions." Pursuant to 40 C.F.R. §§ 124.16(a)(2)(ii) and 124.60(b), this letter notifies you of my determination that the Contested Conditions are stayed until final agency action under 40 C.F.R. § 124.19(f). With respect to each of the Contested Conditions, the corresponding term in the Prior Permit, if any, shall remain in effect pending resolution of Board proceedings.

All conditions of the Permit other than the aforementioned Contested Conditions are uncontested and severable from the Contested Conditions. Thus, all of the other conditions are not stayed and will become fully effective enforceable obligations of the Permit thirty days after the date of this notice, pursuant to 40 C.F.R. §§ 124.16(a)(2)(i) and 124.60(b)(5).
