TENTH JOINT STATUS REPORT

Respondent Region 1 of the United States Environmental Protection Agency ("Region") and Petitioner Town of Uxbridge Sewer Commission ("Uxbridge") hereby submit this Joint Status Report to inform the Environmental Appeals Board ("Board") that the parties have negotiated a settlement of this matter. Pursuant to the settlement, the parties will enter an Order for Compliance on Consent ("Order"). Though the parties have negotiated the terms of the settlement, they need some additional time for Uxbridge and the Region to review and formally approve the negotiated settlement.

The parties anticipate that Uxbridge will review and approve the settlement during the next scheduled meeting of its Sewer Commission/Board of Selectman on Tuesday, April 1, 2014. At that time, the parties anticipate that Uxbridge will execute the Order. Uxbridge will transmit the executed Order to the Region for execution. Once the Region executes and issues the Order, Uxbridge will submit a Request for Leave to Withdraw Its Petition to the Board. To accommodate this schedule, the parties are simultaneously submitting a Joint Motion for Extension of Time to request a brief two

week extension of the current stay of proceedings from March 28, 2014 to April 11, 2014 to complete the final steps in settlement.
