### SECOND JOINT MOTION FOR STAY OF PROCEEDINGS AND AN EXTENSION OF THE RESPONSE DATE

By Joint Motion filed on July 6, 2004, Region I of the Environmental Protection Agency ("Region"), Respondent, and City of Newburyport, Massachusetts ("Newburyport"), Petitioner, sought a stay of the proceedings in the above-captioned matter until October 29, 2004, based upon the belief that resolution of some or all of the issues in this appeal was possible. The Environmental Appeals Board (the "Board") granted the motion by order dated July 7, 2004. The parties have met and made considerable progress toward a resolution of Newburyport's June 3, 2004 Petition for Review. In order to have sufficient time to conclude negotiations, the Region and Newburyport request that the Board stay the proceedings and extend the date for the Region to file a response in this case from October 29, 2004 to January 15, 2005.
