NOW COMES the Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY ("Illinois EPA"), by and through one of its attorneys, and in response to an inquiry by the Environmental Appeals Board ("Board") provides Additional Information in Support of Illinois EPA's Motion for Extension of Time to File Response in the above-captioned matter.

1. 
