## ORDER ELECTING TO REVIEW SUA SPONTE

On October 26, 2005, Administrative Law Judge Spencer T. Nissen ("ALJ") issued a "recommended decision" in this matter.<sup>1</sup> See Recommended Decision on Application for Award of Fees and Expenses Pursuant to the Equal Access to Justice Act ("Recommended Decision"), Dkt. No. CWA-10-2000-0188 (ALJ Oct. 26, 2005). The Recommended Decision denies the application for attorneys fees filed by Donald Cutier pursuant to the Equal Access to Justice Act, 5 U.S.C. § 504 and 40 C.F.R. Part 17.

Pursuant to 40 C.F.R. § 22.30(a), the parties had thirty days to appeal the ALPs decision. The Board did not receive an appeal from either party. Accordingly, we must determine whether to exercise our discretion to initiate review of the case. See 40 C.F.R. § 22.30(b) (the Board may review an initial decision on its own initiative).

After conducting a preliminary examination of the Recommended Decision and related materials, we find that further review is appropriate. We therefore elect to review of this matter pursuant to 40 C.F.R. § 22.30(b). We will not set a briefing schedule at this time but will instead
