## PETITIONERS' RESPONSE TO IEPA'S MOTION FOR EXTENSION OF TIME TO FILE RESPONSE

On October 29, 2007, Petitioners filed a motion for leave to file a reply brief responding to IEPA's September 25, 2007 Partial Response to Petition, and to ConocoPhillips' memorandum in support of its motion to participate. The motion requested permission to file the brief in two parts: the first part (which accompanied the motion) concerning the Responsiveness Summary issues addressed in IEPA's partial response, and the second part to be filed after IEPA filed the remainder of its response to the Petition on October 29, the deadline established by the Board. Petitioners requested permission to file their response to the October 29 IEPA filing on November 26.

On October 29, after filing that motion, Petitioners received the motion of IEPA requesting an 8-day extension of time to file the remainder of its response to the Petition, until November 6.
