MOTION TO FILE SURREPLY TO PETITIONERS' ADDENDUM

I. INTRODUCTION

On June 17, 2009, the Environmental Appeals Board ("Board") granted a motion filed by Petitioners Joel Lamplot and Teri Lamplot ("Petitioners") to file an addendum to their petitions for review of four final National Pollutant Discharge Elimination System ("NPDES") permits issued by the United States Environmental Protection Agency, Region 7 ("EPA"). A subsequent filing by the Board on June 25, 2009 granted Petitioners' request to extend the filing of Petitioners' addendum until July 20, 2009.

After review of Petitioners' addendum, EPA wishes to respond to Petitioners' assertions that the 2009 Supreme Court decision, *Hawaii v Office of Hawaiian Affairs*, 129 S. Ct. 1436 (2009), applies to Petitioners' request for review of the four NPDES permits in the present case.
