#### NINTH JOINT STATUS REPORT

Region 1 of the United States Environmental Protection Agency ("Region") and the Town of Uxbridge Sewer Commission ("Uxbridge") hereby provide the Environmental Appeals Board ("Board") with an update of the progress of negotiations in the above-captioned matter. The parties continue to make progress toward a negotiated settlement of the appeal. The parties convened on March 18, 2014 to discuss the proposed Administrative Order on Consent and largely agreed on adjustments to the order that will likely resolve the remaining issues.

#### BACKGROUND

On June 18, 2013, the Region issued National Pollutant Discharge Elimination System Permit No. MA0102440 ("NPDES Permit") to Uxbridge. On July 19, 2013, Uxbridge filed a Petition for Review ("Petition") with the Board requesting review of certain conditions of the NPDES Permit. The Board granted the parties' joint motion for a stay on July 30, 2013 and the parties' subsequent joint motions to extend the stay. The Board's February 24, 2014 Order stayed the proceedings until March 28, 2014 and, *inter alia*, required the parties to file a Status Report by March 21, 2014.

## **STATUS REPORT**

Since the last filing, the parties have continued to make progress towards finalizing a settlement. On March 18, 2014, the parties met at the EPA offices in Boston to discuss the outstanding issues and largely agreed on appropriate refinements to the proposed order to resolve them. Accordingly, the Region is making final revisions to the order, which it intends to share with Uxbridge early next week. The parties are optimistic that final agreement on the proposed order can be reached prior to the expiration of the stay.
