JOINT MOTION FOR EXTENSION OF TIME

Respondent Region 1 of the United States Environmental Protection Agency ("Region") and Petitioner Town of Uxbridge Sewer Commission ("Uxbridge") hereby respectfully request that the Environmental Appeals Board ("Board") grant a brief two week extension of the current stay of proceedings from March 28, 2014 to April 11, 2014.

As set forth in the Joint Status Report, parties have negotiated a settlement of this matter. Pursuant to the settlement, the parties will enter an Order for Compliance on Consent ("Order"). Though the parties have negotiated the terms of the settlement, they need some additional time for Uxbridge and the Region to review and formally approve the negotiated settlement. A brief two week extension of the current stay of proceedings from March 28, 2014 to April 11, 2014, will give the parties the opportunity to present the settlement for review by the Uxbridge Sewer Commission/Board of Selectman, and permit time for execution and issuance of the Order. Thereafter, Uxbridge will file a request for leave to withdraw the appeal.

For these reasons, the parties respectfully request that the Board grant an extension of the stay of proceedings through April 11, 2014.
