

Comes the Respondent, Gene A. Wilson, and states the following:


1. On December 9, 2008, EAB granted Respondent an additional fifteen (15) days to file his Brief on or before January 15, 2009.
2. The Order granting additional time to file Appeal Brief was sent certified mail from Washington, DC on December 9, 2008 and received by Respondent two (2) days later on December 11, 2008.
3. Respondent mailed his nineteen (19) page Appeal Brief by Certified Mail on January 8, 2009 to EAB; however, checking on Thursday, January 15, 2009, it was noted the Brief was not posted on the EAB's web page.
4. On Monday, January 19, 2009, by United States Postal Service, Tracking & Confirmation, the Brief was received on January 18, 2009, (ten (10) days after mailing) by the Washington, D.C. Post Office. See attached tracking record marked Exhibit "A".


