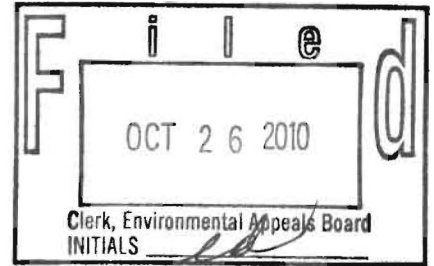

ORDER SCHEDULING ORAL ARGUMENT

In the matter of Vulcan Construction Materials, LP, ("Vulcan"), PSD Appeal No. 10-11, the Board has determined that oral argument may be of assistance in its deliberations.

Accordingly, the parties are ordered to participate in oral argument beginning at 10:30 a.m. on Tuesday, December 14, 2010, in the Administrative Courtroom, U.S. Environmental Protection Agency, EPA East Building, Room 1152, 1201 Constitution Avenue, N.W., Washington, D.C.

Oral argument shall proceed as follows: (1) thirty minutes for Petitioner, the Sierra Club; (2) fifteen minutes for the permit issuer, the Illinois Environmental Protection Agency; and (3) fifteen minutes for Vulcan, the permittee in this matter. At the outset of the proceedings, Petitioner may reserve up to five minutes of its allocated time for rebuttal.

The parties shall notify the Clerk of the Board in writing by Tuesday, November 30, 2010, of the names of counsel who will present argument. Counsel for the parties are advised that the Administrative Courtroom is equipped with state-of-the-art video-conferencing equipment and, accordingly, any party may participate in the oral argument by video-conference rather than attending in person. Counsel who wish to participate in this oral argument via video-

conferencing shall contact the Clerk of the Board, at 202-233-0122, no later than Tuesday November 30, 2010, to make arrangements for use of the video-conference equipment.


