#### MOTION FOR STAY, and FOR ACCELERATED DECISION

In accordance with 40 C.F.R. § 124.19(f) (2012), Petitioner, the Town of Bridgewater (the "Town"), respectfully requests that the Environmental Appeals Board ("EAB" or "Board") stay its ruling on the Motion to Dismiss the Town's Petition as Untimely and to Stay the Filing of the Response to Petition and Certified Index of the Administrative Record, filed by the U.S. Environmental Protection Agency, Region 1 ("EPA").

Pursuant to 40 C.F.R. 124.19(a)(2012), the Town filed the above-captioned appeal of the NPDES Permit issued by EPA to the Town of Bridgewater Board of Water and Sewer Commissioners for the Taunton River Basin MA62-13. EPA's Motion to Dismiss, the Town's Opposition, and EPA's Reply cover EPA's allegation that the Town failed to timely effectuate service of its Appeal on the Board; as well as the Town's response that EPA failed to timely effectuate notification of the date of Permit issuance on the Town, and of the sudden death of the Town official upon whom EPA did serve notification.

The Town is seeking to stay the Board's ruling on the Motion to Dismiss for several reasons. First, late last week, the Town engaged Rubin and Rudman, LLP's Bernice I.

Corman as Environmental Counsel to assist the Town in this matter. Ms. Corman is new to the record, and requires time to familiarize herself with its contents.

Second, the Town was hopeful, in part, based upon representations made by EPA, that the parties would be able to jointly explore whether they could resolve their differences over the above-captioned Permit by negotiating a settlement that would be mutually acceptable to both parties and environmentally beneficial. The Board's denial of EPA's Motion to Dismiss would allow EPA and the Town to focus their attention on such objective, and thereby conserve their resources, as well as those of this Honorable Board.

EPA does not assent to the Town's Motion to Stay.
