STATUS REPORT ON PERMIT MODIFICATION AND JOINT MOTION FOR A STAY OF THE PETITION UNTIL JANUARY 31, 2008

Counsel for Petitioner, South Carolina Electric &Gas Company (SCE&G) and the U.S. Environmental Protection Agency (EPA) Region 4 have in the past jointly requested that the Environmental Appeals Board (EAB) stay all proceedings in the above-captioned matter. Most recently, the EAB granted a stay, until November 16, 2007.

As noted previously, EPA issued a notice of the proposed permit modification on January 11, 2007 seeking public comment and Section 401 Certification from the State. The public comment period closed and only SCE&G commented on the proposed permit. The state issued a section 401 certification on February 19, 2007. The Section 401 Certification was challenged by the Petitioner on March 6, 2007. Under state law, that challenge prevents the certification from taking effect. At this point the challenge process has not been concluded, there is a hearing scheduled for March 2008, and thus there is no effective certification at this time.

Discussions continued regarding the mercury limits and we reported to the EAB that we reached agreement on the mercury issue. Petitioner plans to

perform a reasonable potential analysis to determine the need for a mercury limit when they have three full years of data, which will occur by mid November 2007. At that time the permit will be reissued with appropriate limits and Petitioner will withdrawal its petition. EPA plans to issue the permit as soon as possible after this analysis is concluded, consistent with EPA regulations, and will address the Section 401 Certification issue by providing a re-opener that will address the final adjudication of that issue, assuming it has not been settled by that time.

For the reasons set forth above, and in the interest of judicial economy, counsel for EPA and SCE&G respectively request that the Joint Motion for a Stay of the Petition pending the completion of the permit modification be granted by the Environmental Appeals Board. EPA anticipates the permit modification process to be completed by January 15, 2008. Therefore, the parties request that the petition be stayed until January 31, 2008.
