ORDER SCHEDULING TELECONFERENCE

On July 16, 2008, the parties in the above-captioned matter, U.S. EPA Region 5 (the "Region") and PPG Industries Ohio, Inc. and PPG Industries, Inc. (collectively "PPG"), filed their seventh motion requesting to stay the proceedings in this case. In their request, the parties represent that they "have successfully negotiated all terms to settle this matter." Joint Request for Extension of Stay (filed July 16, 2007). The parties, however, ask that the Board issue an order continuing the stay of these proceedings until September 2008: "[(1)]to obtain final approval of the agreed terms[;] [(2)]to determine the appropriate vehicle for making the agreed modifications to the permit[;] and [(3)]to implement those modifications." Id.

The Board will hold a teleconference, before ruling on the joint motion, to better understand the premise of the parties'

request. In particular, the Board would like to understand: (1)

why the parties represent that the matter is "settled," yet also

state that the matter is not "finalized" (i.e., need to obtain

final approval); (2) why "all terms necessary to settle this

matter" are "successfully negotiated," yet the "vehicles" are

evidently not settled; (3) what "vehicles" the parties are

considering for making the agreed modifications; and (4) why

implementation of the permit modifications is relevant to the

proceedings before the Board. The parties should also be prepared

to respond to any other related questions the Board may ask.

Accordingly, the parties are hereby requested to participate

in a conference beginning at 11:00 a.m. EST on Wednesday, July 23,

2008. The participants should notify the Clerk of the Board of a

contact phone number by no later than Monday, July 21, 2008. The

Clerk of the Board can be reached at (202) 233-0122. The Clerk of

the Board will initiate the conference call.
