## REQUEST OF PETITIONER UNIVERSITY OF MASSACHUSETTS BOSTON FOR LEAVE TO WITHDRAW PETITION

Petitioner University of Massachusetts Boston ("UMass Boston"), with the assent of respondent United States Environmental Protection Agency, Region 1 ("Region"), requests leave to withdraw its petition in this matter pursuant to 40 C.F.R. § 124.19(k).

On March 11, 2013, UMass Boston filed a petition for review of National Pollutant Discharge Elimination Permit ("NPDES") No. MA 0040304 as issued by the Region on February 7, 2013. These proceedings have been stayed by order of the Environmental Appeals Board since April 2, 2013 to allow the parties sufficient time to resolve this matter through settlement.

The parties have agreed to the terms of a settlement by which UMass Boston will withdraw its petition and NPDES No. MA 0040304 will take effect on a date to be set by the Region's final permit decision. Subsequent to the effective date of NPDES No. MA 0040304, the Region will issue a Consented To Order For Compliance ("Order") pursuant to Section 309(a)(3) of the Clean Water Act, as amended (the "Act"), 33 U.S.C. § 1319(a)(3). The Order will establish alternative deadlines for UMass Boston's compliance with certain provisions of NPDES No. MA 0040304.

Accordingly, UMass Boston requests leave to withdraw its petition and requests

dismissal of its petition so as to enable the Region to issue a timely final permit decision as

described.

UMass Boston represents that its undersigned counsel has discussed this request with
