JOINT MOTION TO EXTEND STAY OF PROCEEDINGS

Region 1 of the United States Environmental Protection Agency ("Region") and the Town of Uxbridge Sewer Commission ("Uxbridge") hereby respectfully request that the Environmental Appeals Board ("Board") extend the current stay of the above-captioned matter to enable the parties to conclude negotiations. The Region has substantially completed a draft administrative consent order to settle the appeal, but requires additional time to gather further information and to complete its internal review before sharing it with Uxbridge. The parties continue to believe that a negotiated settlement is likely and, accordingly, respectfully request that the Board extend the stay to February 28, 2014.

BACKGROUND

On June 18, 2013, the Region issued National Pollutant Discharge Elimination System Permit No. MA0102440 ("NPDES Permit") to Uxbridge. On July 19, 2013, Uxbridge filed a Petition for Review ("Petition") with the Board requesting review of certain conditions of the NPDES Permit. The Board granted the parties' joint motion for

a stay on July 30, 2013 and the parties' joint motion requesting an extension of the stay on October 29, 2013. The latter order stayed the proceedings until December 31, 2013.

RELIEF REQUESTED AND GROUNDS FOR RELIEF

As indicated in the last status report, the Region began preparing a consented-to administrative order last month that it expects will enable a negotiated resolution of this appeal. To that end, the Region has substantially completed the draft order, which it intends to share with Uxbridge following internal review of the document. Preliminary internal review has identified the need for an additional, limited exchange of information and discussion between technical staffs of EPA and Uxbridge regarding an issue that will be material to the shape of any final settlement. This exchange of information has already begun, and is expected to be completed in the near term. Previously scheduled year-end vacations of key Region 1 personnel, however, have necessitated that the internal review of the draft order in light of the new information will likely not be complete until into the New Year.

Nonetheless, the parties remain fully committed to negotiating a settlement of this matter and, accordingly, respectfully request that the Board extend the current stay until February 28, 2014 to enable the parties to focus on preparing a suitable order. If, however, the stay is not continued, the Region will be forced to shift already scarce legal and technical resources away from developing an order to preparing a Response to the Petition that it currently anticipates would be unnecessary. Furthermore, once the Region filed such a Response, the Town would be forced to turn its focus to review of that Response and its options for how to respond thereto, rather than to the settlement of this matter. While this would not preclude the later resumption of settlement negotiations, it

will certainly delay them and could ultimately derail them. The parties believe that, if the

proceeding is stayed, they will be able to focus more fully on negotiations and reach a

settlement of this appeal.

CONCLUSION

In light of the foregoing, the Region and Uxbridge jointly request that the Board

(1) extend the stay of these proceedings until February 28, 2014, (2) require the parties to

file a fourth joint status report on the settlement negotiations by January 31, 2014, and (3)

extend the due date for the Region's Response to the Petition and the filing of an index to

the administrative record until March 31, 2014.
