Dear Mr. Welsh:

I am pleased to submit the enclosed revision to the State of Delaware State Implementation Plan (SIP) for the Attainment and Maintenance of the National Ambient Air Quality Standards for Ozone. The revision adds a new regulation, Regulation No. 1144 – CONTROL OF STATIONARY GENERATOR EMISSIONS and amends Regulation No. 1102 - PERMITS. Regulation No. 1144 will impact any owner of a stationary generator, except the owner of any: mobile generator; residential generator for emergency use only; certain generators whose emissions are already well controlled; or generators with a standby power rating of 10 kW or less. The amendments to Regulation No. 1102 will clarify the permitting requirements for owners of stationary generators. The effective date of this regulation is January 11, 2006. We apologize for the lateness of this submittal; it was brought to our attention by your Air Quality Planning Branch, that this had not been received by Region III.

The requirements of the CAA Section 110(a)(2)(A) have been met through the normal public hearing process established by the State of Delaware with proper notification (30 days) prior to the convening of the public hearing. Attachments A and B are copies of affidavits as proof of proper notification. It is the position of the State of Delaware that all minimum requirements set forth in the 1990 Clean Air Act Amendments have been met.
