ANY WHERE EXCEPT THROUGH THE SPILWAUKEE
IT IS ~~NEARLY~~ 2 MILES FROM OUR BARNS TO
MIDDLE CREEK - IT WOULD TAKE A ~~LOT~~
TREMENDOUS AMOUNT TO EVER REACH MIDDLE
CREEK - WE GOT THESE BARNS AS A
SUPPLEMENT INCOME THERE IS NO WAY
I COULD GET ENOUGH MONEY TO PAY
THIS KIND OF RENT - OUR ACCOUNTANT WAS
SUPPOSED TO SEND YOU A REPORT - HE
TOLD MY WIFE THIS WEEK THAT HE
WOULD SEND THEM WHEN WE PAID HIM FOR

IS NO INCOME FROM THEM



I HAVE MADE SEVERAL PHONE CALLS ABOUT THIS WHICH I THOUGHT WOULD BE OKAY - MY WIFE MAILED AT LEAST TWO LETTERS BUT SHE DIDN'T REGISTER THEM. THIS WILL BE REGISTERED. THE WEEK THIS HAPPENED WE HAD 10 INCHES OF RAINFALL - CAMP AR IS 2 MILES FROM US AND THEY HAD $9\frac{1}{2}$ INCHES - WE SENT MEN WITH SHOVELS BELOW THE SPILWAY TO DIVERT THE WATER. WE HAVE SPREADING EASEMENTS OVER MORE THAN ENOUGH LAND TO HANDLE THE SPILL. IF THERE IS MORE CORRESPONDENCE REQUIRED, I WILL MAKE A CONCENTRATED EFFORT TO ANSWER IT PROPERLY. WE HAVE A VERY LIMITED INCOME + THE BARN EXPENSE IS TERRIBLE.
