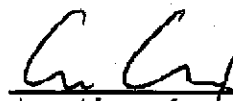

Petitioners American Bottom Conservancy and Sierra Club ("Petitioners") submit this response to the Renewal of Motion for Expedited Consideration ("Renewal Motion") submitted by Respondent ConocoPhillips Company ("ConocoPhillips").

Petitioners note that the Renewal Motion does not differ in relevant substance from ConocoPhillips' previously filed motions for expedited consideration, and therefore reiterate their response dated December 7, 2007. Petitioners further note that the Renewal Motion is ConocoPhillips' third request for expedited consideration, and that the Renewal Motion presents no newly-available information of which the Board is otherwise unaware. Such repeated duplicative filings are an unnecessary burden on the litigants and this Tribunal.
