STATUS REPORT ON PERMIT MODIFICATION

On May 4, 2006, the City of Newburyport (the "City") and the New England Regional

Office of the U.S. Environmental Protection Agency (the "Region") filed a Settlement

Agreement in this matter. Under the terms of the Settlement Agreement, the Region agrees to,

among other things, modify the City's NPDES permit in certain respects and issue a public

notice of the draft permit modification within 60 days of execution of the Settlement Agreement.

On May 9, 2006, the Environmental Appeals Board (the "Board") issued an order further staying the proceedings in this matter until December 15, 2006, and requiring submission of status reports by July 31 and September 29, 2006.

On June 7, 2006, the Region notified the Board that it had public noticed a permit modification and that it would apprise the Board of when the permit modification is finalized.

As of this date, the public comment period on the permit modification has closed. The Region did receive comments on the permit modification from several interested entities and has completed a draft response to those comments which is being circulated for signature and approval by the appropriate representatives at EPA and which will be issued shortly.

The parties intend to notify the Board once the permit modification is finalized and will, as required by the Board's May 9, 2006 Order, move the Board to withdraw the pending Petition

for Review in accordance with the remaining terms of the Settlement Agreement.
