## Re: Notice of Contested and Uncontested Conditions of NPDES Permit MA0101923

Dear Ms. Durr, Ms. Woods, and Mr. Laughlin:

On March 1, 2006, the North and South Rivers Watershed Association ("Petitioner") filed a Petition for Review of NPDES permit MA0101923 ("Permit") with the Environmental Appeals Board ("Board") pursuant to 40 C.F.R. § 124.19(a). The Permit had been reissued to the Permittee on January 26, 2006 by the New England Regional Office of the U.S. Environmental Protection Agency ("Region"). The Permit superseded the permit issued by the Region on August 4, 1999 ("Prior Permit").

## Contested Conditions

In its Petition, the Petitioner contests the following limits and conditions of the Permit: (i) summer phosphorous effluent limit (April 1 - October 31), and (ii) compliance schedules for the summer phosphorous limit (April 1- October 31) and cold weather ammonia nitrogen limits

(October 1 - March 31 and April 1- May 31). The effluent limits for ammonia nitrogen (October 1 - March 31 and April 1 - May 31) are not contested but are unseverable from the compliance schedule for these limits. The Petitioner also contests the absence of mass loading limits for phosphorous and the absence of more prescriptive conditions in the inflow/infiltration control plan (section D.3.).

Uncontested and Severable Conditions

All other conditions of the Permit are uncontested and severable from the Contested Conditions.

The limits and conditions contested by the Petitioner are collectively referred to herein as the "Contested Conditions." Pursuant to 40 C.F.R. §§ 124.16(a)(2)(ii) and 124.60(b), this letter notifies you of my determination that the Contested Limits and unseverable conditions are stayed until final agency action under 40 C.F.R.§ 124.19(f). All other conditions of the Permit are uncontested and severable from the Contested Conditions. Thus, all of the other conditions are not stayed and will become fully effective enforceable obligations of the Permit thirty days from the date of this notice, as provided by 40 C.F.R. §124.16(a)(2)(i). With respect to each of the Contested Conditions and unseverable conditions, the corresponding term, if any, in the Prior Permit shall remain in effect.
