- 1. The extension is requested because the factual and legal background of the appeal is complex and technical and requires review of an administrative record that spans over 20 years.
- 2. 40 C.F.R. § 124.19 contemplates that the Board may grant a 30-day extension for the filing of an appeal brief in appropriate circumstances, and the size and complexity of the record here provide just such circumstances.

3. HRI did not oppose a similar extension requested by EPA in the prior appeal of the RCRA Permit for this Site, and EPA Region 1 does not oppose the extension requested by Appellants herein.

WHEREFORE, Appellants Housatonic River Initiative and Housatonic Environmental Action League hereby respectfully request that the Board grant them until March 5, 2021 to file their appeal brief in this case.
