Enclosed is a petition dated May 10, 2007 (received by the Environmental Appeals Board (the "Board") on May 14, 2007), filed by Donald P. Gallo and Pamela Schaefer, on behalf of Environmental Geo -Technologies, LLC, asking the Board to review the denial of a permit transfer request by U.S. Environmental Protection Agency, Region 5.

To assist the Environmental Appeals Board in deciding whether the matters raised by petitioners should be reviewed, please have your staff prepare a response that addresses the petitioners' contentions and whether petitioners have satisfied the requirements for obtaining review under 40 C.F.R. §124.5(b). Include relevant portions of the administrative record with the response, together with a certified index of the entire administrative record. Please file an original (signed in blue ink) and five copies of these materials no later than July 2, 2007, and send a copy of the response and the certified index to petitioners with a certificate of service showing the date and method of service.¹

All documents, including the materials due July 2, 2007, must reference the appeal
