CONSENT AGREEMENT

I. PRELIMINARY STATEMENT

1. This is a civil administrative action commenced and concluded under section 14(a) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), 7 U.S.C. § 136l(a), and sections 22.13(b), 22.18(b) and (c) of the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits (Consolidated Rules of Practice), as codified at 40 C.F.R. part 22.

2. Complainant is the Director of the Office of Civil Enforcement, Office of Enforcement and Compliance Assurance, U.S. Environmental Protection Agency (EPA). Complainant has been delegated the authority to sign consent agreements resolving enforcement actions in multi-regional matters. EPA Delegation 5-14 (May 11, 1994; Administrative Update Feb. 4, 2016); OECA Redefinition 5-14 (Sept. 2015).

3. Respondent is Electrolux Home Products, Inc. (Electrolux), a corporation doing business in the United States, headquartered at 10200 David Taylor Drive, Charlotte, North Carolina, 26262-2373.

4. Complainant and Respondent (collectively, the parties), agree to settle this action without the filing of a complaint or the adjudication of any issue of fact or law, agree to comply

with the terms of this Consent Agreement, and consent to the issuance of a final order ratifying this Consent Agreement.

II. JURISDICTION

5. The Consolidated Rules of Practice govern all administrative adjudicatory proceedings for the assessment of any administrative civil penalty under section 14(a) of FIFRA, 7 U.S.C. § 136l(a). 40 C.F.R. § 22.1(a)(1).

6. This is a civil administrative action for civil penalties under section 14(a) of FIFRA, 7 U.S.C. § 136l(a), for violations of sections 12(a)(1)(A) and 12(a)(1)(N) of FIFRA, 7 U.S.C. §§ 136j(a)(1)(A) and 136j(a)(2)(N).

7. The U.S. EPA Environmental Appeals Board (the Board) approves settlement of proceedings that are commenced by EPA Headquarters under the Consolidated Rules of Practice and which seek the assessment of civil penalties under section 14(a) of FIFRA. 40 C.F.R. § 22.4(a)(1); EPA Delegation 5-15-B (May 11, 1994).

8. Where the parties agree to settle one or more causes of action before the filing of a complaint, an administrative action may be commenced and concluded simultaneously by the issuance of a consent agreement and final order (CAFO). 40 C.F.R. § 22.13(b).

9. A consent agreement becomes effective when the Board executes a final order ratifying the agreement and files the CAFO with the Clerk of the Board. 40 C.F.R. §§ 22.13(b)(3), 22.31.

III. GOVERNING LAW

10. The importation of pesticides into the United States is governed by sections 17(c) and (e) of FIFRA, 7 U.S.C. §§ 136o(c) and 136o(e), and the regulations promulgated thereunder in consultation with the Administrator of the EPA, set forth at 19 C.F.R. §§ 12.110 - 12.117. 19 C.F.R. § 12.1(b).

11. The regulation at 19 C.F.R. § 12.111 states, in pertinent part, that certain imported pesticides are required to be registered under section 3 of FIFRA and the regulations promulgated thereunder (40 C.F.R. part 152) before being permitted entry into the United States.

12. The regulation at 19 C.F.R. § 12.112(a) states, in pertinent part, that an importer or the importer's agent desiring to import pesticides or devices into the United States shall submit to the EPA, prior to the arrival of the shipment in the United States, a Notice of Arrival of Pesticides and Devices on U.S. EPA Form 3540-1, or, in the alternative, file the electronic version of Form 3540-1, with the filing of the entry documentation, via any electronic data interchange system authorized by the U.S. Customs and Border Protection (CBP). (Herein, both the physical Form 3540-1 and its electronic alternative are referred to as an "NOA").

13. The term "importer" is defined at 19 C.F.R. § 101.1 as the person primarily liable for the payment of any duties on the merchandise, or an authorized agent acting on his behalf. The importer may be the consignee, importer of record, the actual owner of the merchandise or the transferee of the merchandise.

14. Section 3(a) of FIFRA, 7 U.S.C. § 136a(a), states that no person in any state may distribute or sell to any person any pesticide that is not registered under FIFRA, except as provided for by the Act.

15. The term "person" is defined in section 2(s) of FIFRA, 7 U.S.C. § 136(s), as any individual, partnership, association, corporation, or any organized group of persons whether incorporated or not.

16. The term "to distribute or sell" is defined in section 2(gg) of FIFRA, 7 U.S.C. § 136(gg), as "to distribute, sell, offer for sale, hold for distribution, hold for sale, hold for shipment, ship, deliver for shipment, release for shipment, or receive and (having so received) deliver or offer to deliver." See also 40 C.F.R. § 152.3.

17. The term “pesticide” is defined in section 2(u) of FIFRA, 7 U.S.C. § 136(u) as, in pertinent part, “any substance or mixture of substances intended for preventing, destroying, repelling, or mitigating any pest.”

18. The regulation set forth at 40 C.F.R. § 152.15 provides in part that “[a] substance is considered to be intended for a pesticidal purpose, and thus to be a pesticide requiring registration, if:

(a) The person who distributes or sells the substance claims, states, or implies (by labeling or otherwise):

(1) That the substance (either by itself or in combination with any other substance) can or should be used as a pesticide; or

(2) That the substance consists of or contains an active ingredient and that it can be used to manufacture a pesticide; or

(b) The substance consists of or contains one or more active ingredients and has no significant commercially valuable use as distributed or sold other than (1) use for pesticidal purpose (by itself or in combination with any other substance), (2) use for manufacture of a pesticide; or

(c) The person who distributes or sells the substance has actual or constructive knowledge that the substance will be used, or is intended to be used, for a pesticidal purpose.”

19. Section 2(t) of FIFRA, 7 U.S.C. § 136(t), defines a “pest” as “any insect, rodent, nematode, fungus, weed, or [] any other form of terrestrial or aquatic plant or animal life or virus, bacteria, or other micro-organism (except viruses, bacteria, or other micro-organisms on or in living man or other living animals) which the Administrator declares to be a pest under section [25(c)(1) of FIFRA].”

20. The regulation at 40 C.F.R. § 152.5 provides that “[a]n organism is declared to be a pest under circumstances that make it deleterious to man or the environment,” including if the organism is “[a]ny fungus, bacterium, virus, prion, or other microorganism, except for those on or in living man or other living animals and those on or in processed food or processed animal feed, beverages, drugs [] and cosmetics [].”

21. The regulations at 40 C.F.R. part 152 “sets forth procedures, requirements and criteria concerning the registration of pesticide products under FIFRA section 3.” 40 C.F.R. § 152.1(a).

22. The regulation at 40 C.F.R. § 152.3 defines “pesticide product” as “a pesticide in the particular form (including composition, packaging, and labeling) in which the pesticide is, or is intended to be, distributed or sold. The term includes any physical apparatus used to deliver or apply the pesticide if distributed or sold with the pesticide.”

23. Section 12(a)(1)(A) of FIFRA, 7 U.S.C. § 136j(a)(1)(A), prohibits any person in any state from distributing or selling to any person any pesticide that is not registered under section 3 of FIFRA, except to the extent authorized by the Administrator under the provisions of the Act.

24. Section 12(a)(2)(N) of FIFRA, 7 U.S.C. § 136j(a)(2)(N), states that it shall be unlawful for any person who is a registrant, wholesaler, dealer, retailer, or other distributor to fail to file reports required by FIFRA.

25. Section 14(a)(1) of FIFRA, 7 U.S.C. § 136l(a)(1), states that any registrant, commercial applicator, wholesaler, dealer, retailer or other distributor who violates any provision of FIFRA may be assessed a civil penalty by the EPA of not more than \$5,000 for each offense. The Federal Civil Penalties Inflation Adjustment Act of 1990, as amended through 2015, 28 U.S.C. § 2461, and its implementing regulations set forth at 40 C.F.R. part 19, increased the amount that can

be assessed to \$20,228 for each offense occurring after November 2, 2015, when assessed on or after January 13, 2020. See 85 Fed. Reg. 1751 (Jan. 13, 2020).

26. Section 14(a)(4) of FIFRA, 7 U.S.C. § 136l(a)(4), provides that the Administrator, in determining the amount of the penalty, shall consider the appropriateness of such penalty to the size of the business of the person charged, the effect on the person's ability to continue in business, and the gravity of the violation.

IV. COMPLAINANT'S FINDINGS OF FACT AND LAW

27. Between January 11, 2020 and May 12, 2020, Respondent imported into the United States approximately 420,000 dehumidifiers and air conditioners that each contained a filter manufactured with nanosilver, and which were labeled and marketed with pesticidal claims (hereinafter, the "Room Air Pesticide Products"). A list of these imports is set forth at Table A.

28. The Room Air Pesticide Products consisted of 79 different models of Frigidaire and Frigidaire Gallery brand dehumidifiers and air conditioners.

29. Respondent imported the Room Air Pesticide Products through the following United States Ports of Entry, each identified below with its unique CBP Port of Entry number:

- a. Boston, MA – 0401
- b. Worcester, MA – 0403
- c. New York / Newark, NJ – 4601
- d. Norfolk, VA – 1401
- e. Wilmington, NC – 1501
- f. Savannah, GA – 1703
- g. Jacksonville, FL – 1803

- i. Columbus, OH – 4103

- j. San Francisco, CA – 2809
- k. Los Angeles / Long Beach, CA – 2704

30. At all times relevant to the allegations herein, Electrolux made the following pesticidal claims¹ on the labels of the Room Air Pesticide Products, in marketing materials for the Room Air Pesticide Products on Respondent’s website, www.Frigidaire.com, or both:

- a. “antibacterial filter”
- b. “antibacterial mesh filter”
- c. “washable antibacterial filter”
- d. “washable antimicrobial filter”
- e. “Anti Microbial Filter
Cleans air by removing harmful bacteria”
- f. “Protects your home from mold and mildew caused by excess moisture – and helps eliminate bacteria in the air that can make breathing difficult”; and
- g. “Our removable, washable filter reduces bacteria, room odors and other airborne particles for a healthier, more comfortable environment.”

31. Respondent provided information to the EPA about the Room Air Pesticide Products, the use of nanosilver in the filter manufacturing process, and the functions of the filter as contained in the Room Air Pesticide Products.

32. At no time relevant to the allegations herein was the nanosilver that was used to manufacture the filters that were contained in the Room Air Pesticide Products registered with the EPA.

¹ Some of these claims appeared in Spanish and French as well as English.

33. The EPA determined that the Room Air Pesticide Products, as manufactured and marketed, were intended to provide an antibacterial benefit to the user.

34. Respondent’s dehumidifiers and air conditioners that each contained a filter manufactured with nanosilver, including specifically the Room Air Pesticide Products, are “pesticides” as defined by FIFRA.

35. The Room Air Pesticide Products were required to be registered with the EPA before being distributed or sold, including imported, in the United States.

36. At no time has Respondent possessed an EPA registration that would authorize it to distribute or sell, including import, the Room Air Pesticide Products in the United States.

37. The 79 models of the Room Air Pesticide Products that were imported represent 19 distinct “pesticide products,” as that term is defined in FIFRA and 40 C.F.R. § 152.3, as follows:

38. Between January 11, 2020, and May 12, 2020, Respondent imported the 19 pesticide product types of the Room Air Pesticide Products on 573 occasions.

39. Between January 11, 2020, and May 12, 2020, Respondent failed to file a NOA in accordance with 19 C.F.R. § 12.112(a) for the import of the Room Air Pesticide Products on 141 occasions.

40. On May 27, 2020, based on its reason to believe that Respondent had distributed, by import, unregistered pesticides in violation of section 12(a)(1)(A) of FIFRA, the EPA issued a Stop Sale, Use or Removal Order (SSURO) to Respondent under the authority in section 13(a) of FIFRA. 7 U.S.C. §§ 136j(a)(1)(A), 136k(a).

41. The SSURO required Respondent to cease selling and distributing all Frigidaire-brand dehumidifier and air conditioner products that contain a filter manufactured with nanosilver and are labeled or marketed with claims indicating they are intended for use against pests.

42. The SSURO also provided for the movement of subject products for the purpose of consolidating the products for a rework project whereby Respondent, among other things, would replace the filter manufactured with nanosilver contained in each unit with a filter that was not manufactured with a pesticidal substance, affix a sticker with modified language over any pesticidal claims on the product packaging, and remove all pesticidal claims made for the subject products in Respondent's online marketing.

43. Respondent offered to rework all dehumidifiers and air conditioners that contained a filter manufactured with nanosilver within its possession regardless of the date those products were imported.

44. Respondent is and was at all times relevant to the allegations herein, a corporation and, therefore, is a “person” as that term is defined in section 2(s) of FIFRA, 7 U.S.C. § 136(s).

45. Respondent’s importation of the Room Air Pesticide Products constitutes an act within the definition of “to distribute or sell” in section 2(gg) of FIFRA, 7 U.S.C. § 136(gg), and 40 C.F.R. § 152.3. Respondent was a distributor of the Room Air Pesticide Products at all times relevant to the allegations herein.

46. Respondent is and was at all times relevant to the allegations herein, an “importer” as that term is defined in 19 C.F.R. § 101.1 and was the importer of record for all of the unlawful imports alleged herein.

47. Respondent was responsible for submitting a NOA in accordance with section 17(c)(1) of FIFRA, 7 U.S.C. § 136o(c)(1), and 19 C.F.R. § 12.112(a), for its imports of the Room Air Pesticide Products.

Liability for the Distribution of Unregistered Pesticides

48. Each of Respondent’s 573 unlawful imports of the Room Air Pesticide Products identified herein constitutes a distribution of unregistered pesticides and is therefore a violation of section 12(a)(1)(A) of FIFRA, 7 U.S.C. § 136j(a)(1)(A).

49. Respondent may be assessed a civil penalty under the authority in section 14(a)(1) of FIFRA for each violation of section 12(a)(1)(A) of FIFRA, 7 U.S.C. § 136j(a)(1)(A). 7 U.S.C. § 136l(a)(1).

Liability for the Failure to File Reports Required by FIFRA

50. Each of Respondent's 141 failures to submit a NOA in accordance with 19 C.F.R. § 12.112(a) for the import of the Room Air Pesticide Products to the United States constitutes a failure to file reports required by section 17(c)(1) of FIFRA, 7 U.S.C. § 136o(c)(1), and is therefore a violation of section 12(a)(2)(N) of FIFRA, 7 U.S.C. § 136j(a)(2)(N).

51. Respondent may be assessed a civil penalty under the authority in section 14(a)(1) of FIFRA for each violation of section 12(a)(2)(N) of FIFRA, 7 U.S.C. § 136j(a)(2)(N). 7 U.S.C. § 136l(a)(1).

V. CIVIL PENALTY

52. Based on an evaluation of the facts alleged in this Consent Agreement, the factors in section 14(a)(4) of FIFRA, and the EPA's Enforcement Response Policy for the Federal Insecticide, Fungicide, and Rodenticide Act (December 2009), Complainant has determined the appropriate penalty to settle this action is \$6,991,400 (Civil Penalty).

53. This Civil Penalty includes a 20% reduction of the gravity-based penalty amount, for purposes of settlement, in acknowledgement of Respondent's good faith efforts to bring the Room Air Pesticide Products into compliance with FIFRA after the discovery of the violations by the EPA.

VI. TERMS OF AGREEMENT

54. Respondent admits the jurisdictional allegations in this CAFO and neither admits nor denies the other allegations set forth in this CAFO.

55. Respondent waives any right to contest the allegations set forth herein and waives its right to appeal the Final Order ratifying this Consent Agreement.

56. The parties agree to submit this Consent Agreement to the Environmental Appeals Board with a request that it be incorporated into a Final Order.

57. Table A is a part of this Consent Agreement.

58. Respondent consents to the assessment of the Civil Penalty in the amount specified in section V of this Consent Agreement and agrees to pay such penalty to the United States within 30 calendar days following the effective date of the Final Order.

59. Respondent agrees to pay the Civil Penalty in the manner specified below:

a. Using any method described on the following website:

<http://www2.epa.gov/financial/additional-instructions-making-payments-epa>;

b. Identifying the payment with “Docket No. FIFRA-HQ-2020-5014”; and

c. Within 24 hours of payment, e-mailing proof of payment to Adrienne Trivedi at trivedi.adrienne@epa.gov (“proof of payment” means, as applicable, a copy of the check, confirmation of credit card or debit card payment, confirmation of wire or automated clearinghouse transfer, and any other information required to demonstrate that payment has been timely made according to EPA requirements, in the amount due, and identified with “Docket No. FIFRA-HQ-2020-5014”).

60. Respondent agrees that it will be liable for stipulated penalties to the EPA for each day it fails to pay the Civil Penalty, or any portion thereof, when due, and for each day it fails to provide proof of such payment. The stipulated penalties owed shall be: \$5,000 per day for each day during the first 15 days, and \$10,000 per day thereafter. All stipulated penalties must be paid in the manner specified in Paragraph 59 of this Consent Agreement.

61. If Respondent does not pay the Civil Penalty or any portion thereof in a timely manner, the EPA may refer the matter to the Attorney General, who will recover such amount by action in the appropriate United States district court under section 14(a)(5) of FIFRA, 7 U.S.C. § 136l(a)(5).

62. Each party agrees to bear its own costs and attorney’s fees in this action.

63. Respondent certifies that, to the best of its knowledge and belief, it is complying with FIFRA, 7 U.S.C. §§ 136 to 136y.

64. The parties consent to service of the filed CAFO by e-mail at the following addresses for their respective counsel: trivedi.adrienne@epa.gov (for Complainant), and jill.jacobson@electrolux.com (for Respondent).

VII. EFFECT OF THIS CONSENT AGREEMENT AND FINAL ORDER

65. In accordance with 40 C.F.R. § 22.18(c), Respondent's full compliance with this Consent Agreement shall only resolve Respondent's liability for all federal civil penalties for the facts and violations alleged in section IV of this CAFO.

66. Nothing in this CAFO shall relieve Respondent of the duty to comply with all applicable provisions of FIFRA and other federal, state, and local laws or statutes, nor shall it restrict the EPA's authority to seek compliance with any applicable laws or regulations.

67. This CAFO does not affect the right of the EPA or the United States to pursue appropriate injunctive or other equitable relief or criminal sanctions for any violations of law.

68. The terms of this CAFO bind Respondent, its successors, and assigns.

69. Each person signing this Consent Agreement certifies that he or she has the authority to sign for the party whom he or she represents and to bind that party to its terms.


70. Penalties paid pursuant to this CAFO are not deductible for federal tax purposes. 28 U.S.C. § 162(f).

71. This Consent Agreement shall become effective after the Board-ratified CAFO is filed with the Clerk of the Board.

The foregoing Consent Agreement in the matter of Electrolux Home Products, Inc., Docket No. FIFRA-HQ-2020-5014, is hereby agreed to and approved for submission to the U.S. EPA Environmental Appeals Board.
