Attached is an Administrative Compliance Order on Consent ("Consent Order") that the United States Environmental Protection Agency ("EPA") is issuing to TMS International LLC ("TMS"). EPA is issuing this Consent Order to TMS pursuant to its authority under Section 113(a) of the Clean Air Act ("CAA" or the "Act"), 42 U.S.C. § 7413(a), for TMS's alleged violation of CAA Section 113(a)(1), 42 U.S.C. § 7413(a)(1), and requirements of the federally enforceable PA SIP, at its metal scrap shredding facility located at 516 Delwar Road, West Mifflin, Allegheny County, Pennsylvania (the "Facility"). The attached Consent Order is effective immediately upon your receipt and requires immediate compliance with the requirements as stated in the Consent Order. Any violation of this Consent Order is subject to civil penalties under Section 113(b)(2) and (d)(1) of the Act, 42 U.S.C. §§ 7413(b)(2) and 7413(d)(1).

As noted above, the attached Consent Order takes effect immediately upon your receipt, whereupon it will remain in effect unless and until terminated in accordance with the requirements of Section I (Termination) therein.
