CONSENT AGREEMENT AND FINAL ORDER

I. PRELIMINARY STATEMENT

- 1. This Consent Agreement and Final Order ("CAFO") is issued under the authority vested in the United States Environmental Protection Agency ("EPA") pursuant to Section 309(g) of the Clean Water Act (herein "the Act"), 33 U.S.C. § 1319(g). This CAFO is issued to simultaneously commence and conclude this proceeding to assess a Class I civil penalty in accordance with 40 C.F.R. §§ 22.13(b) and 22.18(b)(2) and (3), as described in the "Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits."
- 2. The Parties agree that settlement of the relevant matters without litigation will save time and resources, that it is in the public's interest, and that the entry of this CAFO is the most appropriate means of resolving such matters. Compliance with all the terms and conditions of this CAFO resolves only those violations alleged herein.
- 3. Respondent admits the jurisdictional allegations herein for the purposes of this proceeding; however, Respondent neither admits nor denies the specific Findings of Fact and Conclusions of Law contained in this CAFO for the purposes of this proceeding.
 - 4. This CAFO states a claim(s) upon which relief may be granted.
- 5. Respondent expressly waives any right to contest, for the purposes of this proceeding, the Findings of Fact or Conclusions of Law contained in this CAFO, and waives its right to appeal the Final Order set forth herein.

6. Before the taking of any testimony and without adjudication of any issue of law or fact, the parties agree to the terms of this CAFO and to its issuance. Respondent consents to the assessment and payment of a civil penalty in the amount and by the method stated below.

II. FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 7. Southwestern Electric Power Company ("Respondent") is a corporation incorporated under the laws of the State of Delaware ("State"), and as such, Respondent is a "person," as that term is defined at Section 502(5) of the Act, 33 U.S.C. § 1362(5), and 40 C.F.R. §§ 122.2 and 232.2. Respondent is a subsidiary of American Electric Power, a corporation incorporated in the State of New York.
- 8. At all times relevant to the violations alleged herein ("relevant time period"),
 Respondent owned real property for the construction of a new coal fired power plant, the John
 W. Turk, Jr. Power Plant, in Hempstead County, Arkansas (herein "the Property").
- 9. As part of the development of the Property, Respondent submitted a permit application to the United States Army Corps of Engineers ("Corps"), which issued public notices of the permit application on March 7, 2007, and July 18, 2008. As part of the permit process, on February 11, 2009, Respondent purchased credits from approved mitigation banks as compensatory mitigation covering, *inter alia*, impacts to wetlands and intermittent streams at a cost of \$274,839.75.
- 10. On or about March 6, 2009, Respondent became aware that wetland 9-1, located in Section 9, T135, R26W, of the Property, may have been graded and partially filled. In response, Respondent initiated an investigation and on or about March 9, 2009, Respondent confirmed that wetland 9-1 had been graded and partially filled and became aware that two other wetland areas on the Property, specifically, wetland area 9, located in Sections 9 and 16, T13S, R26W, and wetland area 15-1, located at Section 9, T13S,

R26W, of the Property, had been graded and partially filled. The combined total acreage of wetlands impacted was approximately 2.5 acres. On March 9, 2009, Respondent reported to the Corps, the results of its investigation, including the location and extent of the impacts.

- 11. On or about December 22, 2008, Respondent's contractor cleared and filled approximately 2.2 acres of wetlands in wetland area 9 of the Property.
- 12. On or about December 19, 2008, Respondent's contractor cleared and filled approximately 0.22 acres of wetlands in wetland area 9-1 of the Property.
- 13. On or about October 3, 2008, Respondent's contractor cleared and filled approximately 0.08 acres of wetlands in wetland area 15-1 of the Property.
- 14. On or about October 3, 2008, December 19, 2008, and December 22, 2008, Respondent discharged, caused the discharge, directed or supervised the discharge, and/or agreed with other persons or business entities, to "discharge dredged material" and/or "discharge fill material," as defined by 40 C.F.R. § 232.2 from point sources, including heavy equipment, in, on and to approximately 2.5 acres of wetlands within the Property, specifically wetland areas 9, 9-1, and 15-1, as those terms are defined by Section 502 of the Act, 33 U.S.C. § 1362, and 40 C.F.R. § 232.2. This work was associated with preparation for construction of a rail spur and loop associated with the proposed power plant, and was done without authorization under a permit issued by the Corps.
- 15. During the relevant time period, the approximately 2.5 acres of wetlands impacted on the Property, specifically wetland area 9, wetland area 9-1, and wetland area 15-1, as described in paragraph 9, *supra*, were "navigable waters" as defined by Section 502(7) of the Act, 33 U.S.C. § 1362(7), and 40 C.F.R. § 232.2.
- 16. The discharged dredged material and fill material are considered "pollutants" as that term is defined at Section 502(6) of the Act, 33

U.S.C. § 1362(6).

- 17. Each piece of equipment used for the discharge(s) acted as a "point source" as that term is defined at Section 502(14) of the Act, 33 U.S.C. § 1362(14).
- 18. Under Section 301(a) of the Act, 33 U.S.C. § 1311(a), it is unlawful for any person to discharge a pollutant from a point source to waters of the United States, except with the authorization of, and in compliance with, a permit issued under the Act.
- 19. Under Section 404 of the Act, 33 U.S.C. § 1344, the Secretary of the Army, acting through the Chief of Engineers for the Corps, is authorized to issue permits for the discharge of dredged or fill material into navigable waters of the United States.
- 20. During the relevant time period, Respondent did not have a permit issued by the Corps authorizing the discharges alleged herein.
- 21. Under Section 309(g)(1)(A) of the Act, 33 U.S.C. § 1319(g)(1)(A), the Administrator is authorized to assess a Class I civil penalty whenever, on the basis of any available information, the Administrator finds that a person violated Section 301 of the Act, 33 U.S.C. § 1311.
- 22. Under Section 309(g)(2)(A) of the Act, 33 U.S.C. § 1319(g)(2)(A), and 40 C.F.R. Part 19, Respondent is liable for a civil penalty of up to \$11,000 per violation, up to a maximum of \$32,500, for violations that occurred after March 15, 2004, to January 12, 2009.
- 23. EPA notified the State of and provided the State an opportunity to consult with EPA regarding the proposed assessment of an administrative penalty against Respondent.
- 24. On May 18, 2009, EPA notified the public of the proposed CAFO through a public notice in the Texarkana Gazette and Hope Star and afforded the public thirty (30) days to comment on the proposed penalty in accordance with 40 C.F.R. § 22.45. At the expiration of the notice period, EPA had not received comments

from the public.

III. TERMS OF SETTLEMENT

A. <u>PENALTY PROVISIONS</u>

- 25. Based on the foregoing Findings of Fact and Conclusions of Law, EPA Region 6, considering the relevant criteria pursuant to Section 309(g)(3) of the Act, 33 U.S.C. § 1319(g)(3), and acting pursuant to the authority of Section 309(g) of the Act, 33 U.S.C. § 1319(g), hereby orders that Respondent shall pay to the United States a civil penalty in the amount of twenty-nine thousand two hundred fifty dollars (\$29,250.00), to settle the violations as alleged in this CAFO, in accordance with 40 C.F.R. § 22.18(c).
- 26. Payment shall be made by one of the following methods within thirty (30) days of the effective date of this CAFO:

Respondent's adherence to these procedures will ensure proper credit when payment is received by EPA.

- 28. Respondent agrees not to claim, or attempt to claim, a federal income tax deduction or credit covering all or any part of the civil penalty paid to the United States Treasurer.
- 29. Pursuant to 31 U.S.C. § 3717 and 40 C.F.R. § 13.11, unless otherwise prohibited by law, EPA will assess interest and late payment penalties on outstanding debts owed to the United

States and a charge to cover the costs of processing and handling a delinquent claim. Interest on the civil penalty assessed in this CAFO will begin to accrue thirty (30) days after the effective date of the CAFO and will be recovered by EPA on any amount of the civil penalty that is not paid by the respective due date. Interest will be assessed at the rate of the United States Treasury tax and loan rate in accordance with 40 C.F.R. § 13.11(a). Moreover, the costs of the Agency's administrative handling of overdue debts will be charged and assessed monthly throughout the period the debt is overdue. See 40 C.F.R. § 13.11(b).

- 30. EPA will also assess a \$15.00 administrative handling charge for administrative costs on unpaid penalties for the first thirty (30) day period after the payment is due and an additional \$15.00 for each subsequent thirty (30) day period that the penalty remains unpaid. In addition, a penalty charge of up to six percent per year will be assessed monthly on any portion of the debt which remains delinquent more than ninety (90) days. See 40 C.F.R. § 13.11(c). Should a penalty charge on the debt be required, it shall accrue from the first day payment is delinquent. See 31 C.F.R. § 901.9(d). Other penalties for failure to make a payment may also apply.
- 31. Pursuant to Section 309(g)(9) of the Act, 33 U.S.C. § 1319(g)(9), any person who fails to pay on a timely basis a civil penalty ordered or assessed under this section shall be required to pay, in addition to such penalty and interest, the United States' enforcement expenses, including but not limited to, attorney's fees and costs incurred by the United States for collection proceedings and a quarterly nonpayment penalty for each quarter during which such failure to pay persists. Such nonpayment penalty shall be twenty (20) percent of the aggregate amount of such person's outstanding penalties and nonpayment penalties accrued as of the beginning of each quarter.
- 32. Failure by Respondent to pay the penalty assessed according to the terms of this CAFO, in full, by its due date, may subject Respondent to a civil action to collect the assessed penalty and any accrued interest and penalties.
- 33. In the event a collection action is necessary, Respondent shall pay in addition to any applicable penalty, fees, and interest described herein all reasonable costs and expenses,

including legal expenses and court costs, incurred by the United States for enforcement and collection proceedings for nonpayment of the amounts agreed hereunder, pursuant to Section 309(g)(9) of the Act, 33 U.S.C. 1319(g)(9). In any such collection action, the validity, amount, and appropriateness of the penalty, and the terms of this CAFO, shall not be subject to review.

B. <u>GENERAL PROVISIONS</u>

- 34. This CAFO shall become effective upon filing with EPA's Regional Hearing Clerk.
- 35. Issuance of this CAFO does not relieve Respondent from responsibility to comply with all requirements of the Act and the requirements of any permits issued thereunder, as described in Section 309(g)(7) of the Act, 33 U.S.C. § 1319(g)(7), nor does it constitute a waiver by EPA of its right to enforce compliance with the requirements of Respondent's permits or other requirements of the Act by actions pursuant to Section 309 of the Act, 33 U.S.C. § 1319.
- 36. The provisions of this CAFO shall be binding upon Respondent, its officers or officials, managers, employees, and their successors or assigns, in their capacity on behalf of Respondent.
- 37. Each party agrees to bear its own costs and attorney's fees in this matter, except to the extent that Respondent may be responsible for reasonable costs and expenses of enforcement and collection proceedings for failure to comply with the terms of this CAFO. Furthermore, Respondent specifically waives its right to seek reimbursement of its costs and attorney's fees under the Equal Access to Justice Act, 5 U.S.C. § 504, as amended by the Small Business Regulatory Enforcement Fairness Act, 5 U.S.C. § 601, and any regulations promulgated pursuant to those Acts.
- 38. Each undersigned representative of the parties to this agreement certifies that he or she is fully authorized by the party represented to enter into the terms and conditions of this agreement and to execute and legally bind that party to it.

FINAL ORDER

Nothing in this Final Order shall be construed to waive, extinguish or otherwise affect Respondent's (or its officers, agents, servants, employees, successors, or assigns) obligation to comply with all applicable federal, state, and local statutes and regulations, including the regulations that were the subject of this action. Respondent is ordered to comply with the terms of settlement and the civil penalty payment instructions as set forth in the Consent Agreement. This CAFO shall become effective upon filing with the Regional Hearing Clerk, pursuant to 40 C.F.R. § 22.31(b).
