Proceeding to Assess a Civil Penalty Under Section 14(a) of the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. § 136*l*(a)

Consent Agreement and Final Order

Preliminary Statement

1. This is a civil administrative action commenced and concluded under Section 14(a) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), 7 U.S.C. § 136*l*(a), and Sections 22.13(b) and 22.18(b)(2) and (3) of the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits (Consolidated Rules) as codified at 40 C.F.R. Part 22.

2. The Complainant is, by lawful delegation, the Director of the Enforcement and Compliance Assurance Division, United States Environmental Protection Agency (EPA or "the Agency"), Region 5.

3. The Respondent is Warner Tech-care Products, LLC (Warner Tech-care), a corporation doing business in the State of Minnesota.

4. Where the parties agree to settle one or more causes of action before the filing of a complaint, the administrative action may be commenced and concluded simultaneously by the issuance of a consent agreement and final order (CAFO). 40 C.F.R. § 22.13(b).

5. The parties agree that settling this action without the filing of a complaint or the adjudication of any issue of fact or law is in their interest and in the public interest.

6. Respondent consents to the assessment of the civil penalty specified in this CAFO, and to the terms of this CAFO.

Jurisdiction and Waiver of Right to Hearing

7. Respondent admits the jurisdictional allegations in this CAFO and neither admits nor denies the factual allegations in this CAFO.

8. Respondent waives its right to request a hearing as provided at 40 C.F.R. § 22.15(c), any right to contest the allegations in this CAFO and its right to appeal this CAFO.

Respondent certifies that, to the best of its knowledge, it is complying with FIFRA,
 7 U.S.C. §§ 136-136y, and the regulation at 40 C.F.R. § 152.132.

Statutory and Regulatory Background

10. Section 12(a)(1)(A) of FIFRA, 7 U.S.C. § 136j(a)(1)(A), states that it is unlawful for any person in any state to distribute or sell to any person any pesticide that is not registered under Section 3 of FIFRA, 7 U.S.C. § 136a.

11. The term "distribute or sell" means "to distribute, sell, offer for sale, hold for distribution, hold for sale, hold for shipment, ship, deliver for shipment, release for shipment, or receive and (having so received) deliver or offer to deliver." 7 U.S.C. § 136(gg).

12. A "pest" is any insect, rodent, nematode, fungus, weed, or any other form of terrestrial or aquatic plant or animal life or virus, bacteria, or other micro-organism which the Administrator of EPA declares to be a pest under Section 25(c)(1) of FIFRA. 7 U.S.C. § 136(t).

13. A "pesticide" is, among other things, any substance or mixture of substances intended for preventing, destroying, repelling, or mitigating any pest. 7 U.S.C. § 136(u).

14. A substance is considered to be intended for a pesticidal purpose, and thus to be a pesticide requiring registration, if the person who distributes or sells the substance claims, states

or implies (by labeling or otherwise) that the substance can or should be used as a pesticide. 40 C.F.R. § 152.15(a)(1).

15. The Administrator of EPA may assess a civil penalty against any registrant, commercial applicator, wholesaler, dealer, retailer, or other distributor who violates any provision of FIFRA of up to \$20,528 for each offense that occurred after November 2, 2015, pursuant to Section 14(a)(1) of FIFRA, 7 U.S.C. § 136*l*(a)(1), and 40 C.F.R. Part 19.

Factual Allegations and Alleged Violations

16. Respondent is a "person" as defined at Section 2(s) of FIFRA, 7 U.S.C. § 136(s).

17. Respondent is an "other distributor" within the meaning of Section 14(a)(1) of FIFRA, 7 U.S.C. § 136*l*(a)(1).

Respondent owned or operated an establishment located at 3796 Dunlap Street,
 North, Arden Hills, Minnesota, during calendar years 2020 and 2021.

19. Respondent distributed products for sale to the hearing healthcare industry.

20. Respondent distributed or sold the following products, among others: "Tech-care Clean Wipes," "Tech-care Clean-Wipes+," "PharmaCare Hand & Surface Disinfecting Wipes" and "Audiologist's Choice Audio Wipes" (aka "Audio Wipes").

21. Each of the products identified above is a "pesticide" as defined at Section 2(u) of FIFRA, 7 U.S.C. § 136(u).

22. On or about January 26, 2021, EPA observed on the website of Warner Tech-care – <u>https://www.warnertechcare.com</u> ("Respondent's website") – advertisements for the following products under a website heading that included the language, "NEED INFECTION CONTROL PRODUCTS? We've been working hard to find and stock COVID-19 prevention items...":

a. Tech-care Clean Wipes+,

b. Tech-care Clean Wipes,

c. PharmaCare Hand & Surface Wipes,

d. Audiologist's Choice Audio Wipes.

23. On or about February 24, 2021, the Minnesota Department of Agriculture (MDA) performed an inspection of the Warner Tech-care establishment at 3796 Dunlap Street, North, Arden Hills, Minnesota ("Inspection").

24. Following the Inspection, MDA requested records from Respondent concerning the Warner Tech-care products identified in Paragraphs 20 and 22.

25. On and after February 24, 2021, Respondent provided records concerning its products and the distribution or sale of those products to MDA.

26. Among the records that Respondent provided to MDA were records that identified each distribution or sale of the products "Tech-care Clean Wipes," "Tech-care Clean-Wipes+," "PharmaCare Hand & Surface Disinfecting Wipes" and "Audiologist's Choice Audio Wipes," during the period between January 1, 2021 and February 24, 2021.

Tech-care Clean Wipes (Distribution or Sale of Unregistered Pesticide)

27. On or about January 26, 2021, EPA observed that Respondent's website displayed the following language regarding the product "Tech-care Clean Wipes":

- a. "Disinfectant wipes designed for hearing healthcare industry"
- b. "Alcohol Free formula ultra fabric wipes are premoistened with a hospital grade disinfectant and are designed to clean ... environmental surfaces such as hearing aids, specula, and headphones"
- c. "Cleaning & disinfecting wipes"
- d. "These disinfecting wipes have been specially created for the daily care of all

types of hearing aid and earmolds."

28. Following the Inspection, Respondent provided to MDA a bin-label dated September 10, 2020, for the product "Tech-care Clean Wipes" that included the following language:

- a. Cleaning & disinfecting wipes
- b. These cleaning and disinfectant wipes have been specially designed for surfaces, instruments, healthcare seats and medical devices.
- c. Composition: 100g of liquid contains:

0.25 g Alkylbenzyldimethylammonium chloride

0.25 g Alkyl dimethyl ethylbenzyl ammonium chloride

0.25 g Didecyldimethylammonium chloride

d. www.warnertechcare.com

29. Records provided by Respondent to MDA demonstrated that Respondent distributed or sold units of "Tech-care Clean Wipes" to other persons on 145 occasions between on or about January 4, 2021, and on or about February 24, 2021, as set forth in Table 1, attached.

30. At the time of each distribution or sale of the product "Tech-care Clean Wipes" identified above, this product was a "pesticide" as defined at Section 2(u) of FIFRA, 7 U.S.C. § 136(u).

31. At the time of each distribution or sale of the product "Tech-care Clean Wipes" identified above, this product was not registered as a pesticide under Section 3 of FIFRA, 7 U.S.C. § 136a.

32. Each of Respondent's distributions or sales of the unregistered pesticide "Tech-care Clean Wipes" constitutes a separate and distinct unlawful act under Section 12(a)(1)(A) of FIFRA, 7 U.S.C. § 136j(a)(1)(A).

Tech-care Clean Wipes + (Distribution or Sale of Unregistered Pesticide)

33. On or about January 26, 2021, EPA observed that Respondent's website displayed the following language regarding the product "Tech-care Clean Wipes+" : "*These cleaning and disinfecting wipes have been specially created for surfaces, instruments, hearing aids, and earmolds*" and "*Cleaning and disinfecting wipes*."

34. In an email sent by Warner Tech-care to its customers on January 14, 2021 (which later was provided by Respondent to MDA), Respondent made the following statements about the product "Tech-care Clean Wipes+": "*From cleaning hard surface areas to hearing aids and earmolds, Clean-wipes+ are the quick and easy way to keep you and your patients clean and safe*" and "*Tech-care Clean Wipes+ are formulated to fight against coronavirus and other viruses*."

35. During the Inspection, the inspector observed and photographed a label for the product "Tech-care Clean Wipes+" (30-wipe containers) that included the following language:

- a. Cleaning and Disinfecting Wipes
- b. These cleaning and disinfectant wipes have been specially created for surfaces, instruments, hearing aids, and earmolds.
- c. 100g of liquid contains:

0,25 g Alkylbenzyldimethylammonium chloride,
0,25 g Alkylethylbenzyldimethylammonium chloride,
0,25 g Didecyldimethylammonium chloride,

d. www.warnertechcare.com

36. The language quoted in paragraph 35, above, also appeared on a bin label which Respondent provided to MDA following the Inspection.

37. During the Inspection, the MDA inspector observed and photographed a label for the product "Tech-care Clean Wipes+" (160-wipe containers) that included the following language:

- a. Cleaning and Disinfecting Wipes
- b. These cleaning and disinfectant wipes have been specially created for surfaces, instruments, hearing aids, and earmolds.
- c. 100g of liquid contains:

0,25 g Alkylbenzyldimethylammonium chloride,

0,25 g Alkylethylbenzyldimethylammonium chloride,

0,25 g Didecyldimethylammonium chloride,

d. www.warnertechcare.com

38. The language quoted in paragraph 37, above, also appeared on a bin label which Respondent provided to MDA following the Inspection.

39. Following the Inspection, Respondent provided a bin label for the product "Techcare Clean Wipes+" (40-wipe containers) dated November 19, 2020, to MDA that included the following language:

- a. Cleaning and Disinfecting Wipes
- b. Ideal for Cleaning: Hearing aids, earmolds, headphones, and assistive listening devices. Safe to use on any hard surfaces or objects such as: counter tops, instruments, sinks, and telephones. Won't harm plastic or rubber.

c. www.warnertechcare.com

40. On or about February 24, 2021, Respondent provided the MDA inspector with a Safety Data Sheet (SDS) for a product named "Audinell Clean Wipes" which Warner Tech-care's Digital Marketing Associate represented to be applicable to the product "Tech-care Clean Wipes+"; this SDS included the following language:

- a. The specific formulation of the solution has virucidal (according to RKI, BGVDD ad DVV), bactericidal (according to EN 13727) and fungicidal (according to EN 14562) actions for a contact time of 1 minute. The solution is effective against enveloped viruses (coronavirus, HIV, hepatitis).
- b. Product composition

Propan-2-ol Methylisothiazolinone Alkylethylbenzyldimethylammonium chloride Didecyldimethylammonium chloride

41. In a "Marketing Email" sent to customers of Warner Tech-care during the week of January 11, 2021 (according to Warner Tech-care's Digital Marketing Associate), which was shared with the MDA inspector on or about February 24, 2021, Respondent made the following statements about the product "Tech-care Clean Wipes+":

- a. Tech-care Clean-Wipes+ are the latest Warner Tech-care disposable wipe. From cleaning hard surface areas to hearing aids and earmolds, Clean-wipes+ are the quick and easy way to keep you and your patients clean and safe.
- b. Tech-care Clean Wipes+ are formulated to fight against Coronavirus and other viruses.

42. Records provided by Respondent to MDA demonstrated that Respondent distributed or sold units of "Tech-care Clean Wipes+" to other persons on 124 occasions between on or about January 4, 2021, and on or about February 24, 2021, as set forth in Table 1, attached.

43. At the time of each distribution or sale of the product "Tech-care Clean Wipes+" identified above, this product was a "pesticide" as defined at Section 2(u) of FIFRA, 7 U.S.C. § 136(u).

44. At the time of each distribution or sale of the product "Tech-care Clean Wipes+" identified above, this product was not registered as a pesticide under Section 3 of FIFRA, 7 U.S.C. § 136a.

45. Each of Respondent's distributions or sales of the unregistered pesticide "Tech-care Clean Wipes+" constitutes a separate and distinct unlawful act under Section 12(a)(1)(A) of FIFRA, 7 U.S.C. § 136j(a)(1)(A).

PharmaCare Hand & Surface Wipes (Distribution or Sale of Unregistered Pesticide)

46. On or about January 26, 2021, EPA observed that Respondent's website displayed the following statements concerning the product "PharmaCare Hand & Surface Wipes":

- a. KILLS 99.99% OF COMMON GERMS
- b. 70% SATURATED WITH ISOPROPYL ALCOHOL
- c. PharmaCare Specialized Institutional Alcohol Wipes are durable, lint free, kill
 99.99% of common germs and are GMP compliant.
- 47. During the Inspection, the inspector observed a label on units of "PharmaCare Hand

& Surface Wipes" that included the following language:

- a. Please refer to MSDS
- b. 70% ISOPROPYL ALCOHOL

- c. KILLS 99.99% OF COMMON GERMS
- d. Wipe over skin or effected area
- 48. The label also included a reference to the website "escbrands.com."

49. On or about September 8, 2021, EPA observed the following statements for the product "PharmaCare Hand & Surface Wipes" on the website "escbrands.com":

- a. Kills 99.99% of germs
- b. Helps prevent the risk of infection
- c. They decrease germs to reduce the risk of infection in minor cuts, scrapes, and burns and sanitize equipment or surfaces. Our handy, disposable wipes can be used for multiple purposes such as sanitizing objects, disinfecting skin, cleaning wounds, and more.

50. On or about September 8, 2021, EPA observed the following statements for the product "PharmaCare Hand & Surface Wipes" on Respondent's website:

- a. PharmaCare 70% isopropyl alcohol wipes are durable, lint free, kill 99.99% of common germs.
- b. Hand & Surface Disinfectant
- c. 70% IPA Wipes
- d. Chemical Name: propan-2-ol
- *e. CAS-No.:* 67-63-0
- f. Concentration: (%) 60 100

51. The Safety Data Sheet for the product "PharmaCare Hand & Surface Wipes" that was available on Respondent's website, and a copy of which also was provided to MDA by Respondent on or about February 24, 2021, identified the active ingredient as "propan-2-ol," and included a recommended use of "Hand & Surface Disinfectant."

52. On or about February 24, 2021, Respondent held the product "PharmaCare Hand & Surface Wipes" for distribution or sale to other persons at its Arden Hills, Minnesota establishment.

53. The act of holding a pesticide for distribution or sale constitutes "distribution or sale" of the pesticide within the meaning of FIFRA, 7 U.S.C. § 136(gg).

54. At the time of the distribution or sale of the product "PharmaCare Hand & Surface Wipes" identified above, this product was a "pesticide" as defined at Section 2(u) of FIFRA, 7 U.S.C. § 136(u).

55. At the time of the distribution or sale of the product "PharmaCare Hand & Surface Wipes" identified above, this product was not registered as a pesticide under Section 3 of FIFRA, 7 U.S.C. § 136a.

56. Respondent's distribution or sale of the unregistered pesticide "Pharmacare Hand & Surface Wipes" constitutes an unlawful act under Section 12(a)(1)(A) of FIFRA, 7 U.S.C. § 136j(a)(1)(A).

Audiologist's Choice Audio Wipes (Distribution or Sale of Unregistered Pesticide)

57. On or about January 26, 2021, EPA observed that Respondent's website displayed the following statements concerning the product "Audiologist's Choice Audio Wipes":

- a. Designed to clean and disinfect hearing aids, headphones, earmolds, ear inserts, specula, and any other hard surface or object
- b. This product contains...Quaternary Ammonium Chloride... dimethyl ethylbenzyl ammonium chlorides
- c. "Active ingredient Quaternary Ammonium Chloride.

58. During the Inspection, the inspector observed a label on units of the product "Audiologist's Choice Audio Wipes" that included the following language:

- a. Environmental Surface Wipes
- b. Contains low pH Synergized Quaternary Ammonium Chloride
- c. Contains CAS Number: Quaternary Ammonium Compounds, Benzyl C12-C16 Alkyldimethyl, Chlorides (68424-85-1)
- d. For additional information see Safety Data Sheet
- e. Safe To Use On All Contact Surfaces

59. On or about February 24, 2021, Respondent held the product "Audiologist's Choice Audio Wipes" for distribution or sale to other persons at its Arden Hills, Minnesota establishment.

60. The act of holding a pesticide for distribution or sale constitutes "distribution or sale" of the pesticide within the meaning of FIFRA, 7 U.S.C. § 136(gg).

61. At the time of the distribution or sale of the product "Audiologist's Choice Audio
Wipes" identified above, this product was a "pesticide" as defined at Section 2(u) of FIFRA,
7 U.S.C. § 136(u).

62. At the time of the distribution or sale of the product "Audiologist's Choice Audio Wipes" identified above, this product was not registered as a pesticide under Section 3 of FIFRA, 7 U.S.C. § 136a.

63. Respondent's distribution or sale of the unregistered pesticide "Audiologist'sChoice Audio Wipes" constitutes an unlawful act under Section 12(a)(1)(A) of FIFRA, 7 U.S.C.§ 136j(a)(1)(A).

Civil Penalty

64. Pursuant to Section 14(a)(4) of FIFRA, 7 U.S.C. § 136*l*(a)(4), Complainant determined that an appropriate civil penalty to settle this action is **Two-Hundred Fifteen**

Thousand Dollars (\$215,000). In determining the penalty amount, Complainant considered the appropriateness of the penalty to the size of Respondent's business, the effect on Respondent's ability to continue in business, and the gravity of the violation. Complainant also considered EPA's FIFRA Enforcement Response Policy, dated December 2009.

65. Within thirty (30) days after the effective date of this CAFO, Respondent must pay a \$215,000 civil penalty for the FIFRA violations identified above by Automated Clearinghouse ("ACH," also known as REX or remittance express) electronic funds transfer, payable to "Treasurer, United States of America," and sent to:

In the comment area of the electronic funds transfer, state Respondent's name, "Warner Techcare Products, LLC," and the docket number of this CAFO.

66. Respondent must send a notice of payment that states Respondent's name and the case docket number to EPA at the following addresses when it pays the penalty:

67. This civil penalty is not deductible for federal tax purposes.

68. If Respondent does not pay timely the civil penalty, EPA may refer the matter to the Attorney General who will recover such amount by action in the appropriate United States district court under Section 14(a)(5) of FIFRA, 7 U.S.C. § 136*l*(a)(5). The validity, amount and appropriateness of the civil penalty are not reviewable in a collection action.

69. Pursuant to 31 C.F.R. § 901.9, Respondent must pay the following on any amount overdue under this CAFO. Interest will accrue on any amount overdue from the date payment was due at a rate established by the Secretary of the Treasury. Respondent must pay a \$15 handling charge each month that any portion of the penalty is more than 30 days past due. In addition, Respondent must pay a 6 percent per year penalty on any principal amount 90 days past due.

General Provisions

70. The parties consent to service of this CAFO by e-mail at the following valid e-mail addresses: <u>cha.james@epa.gov</u> (for Complainant), and <u>eschmiesing@winthrop.com</u> (for Respondent). Respondent understands that the CAFO will become publicly available upon filing.

71. The Respondent's full compliance with this CAFO resolves only Respondent's liability for federal civil penalties for the violations alleged in the CAFO.

72. This CAFO does not affect the rights of EPA or the United States to pursue appropriate injunctive or other equitable relief or criminal sanctions for any violations of law.

73. This CAFO does not affect Respondent's responsibility to comply with FIFRA and other applicable federal, state and local laws.

74. This CAFO is a "final order" for purposes of EPA's FIFRA Enforcement Response Policy.

75. The terms of this CAFO bind Respondent, its successors and assigns.

76. Each person signing this agreement certifies that he or she has the authority to sign for the party whom he or she represents and to bind that party to its terms.

- 77. Each party agrees to bear its own costs and attorneys' fees, in this action.
- 78. This CAFO constitutes the entire agreement between the parties.
