COMPLAINT

This civil administrative enforcement action is issued pursuant to Section 113(a)(3)(B) of the Clean Air Act, 42 U.S.C. § 7413(a)(3)(B), for violation of the implementing regulations associated with the "Stratospheric Ozone Protection" requirements of Subchapter VI, Section 608, 42 U.S.C. § 7671g. This proceeding is subject to EPA's "Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation or Suspension of Permits" (Rules of Practice), 40 C.F.R. Part 22, and this COMPLAINT AND CONSENT AGREEMENT is authorized by the rules. 40 C.F.R. § 22.13(b). The undersigned EPA officials have been properly delegated the authority to issue this action.

STATUTORY AND REGULATORY FRAMEWORK

1. The regulations promulgated by EPA pursuant to authority under the CAA, implementing the "Stratospheric Ozone Protection" requirements, are set forth in Part 82. Subpart F of Title 40 of the Code of Federal Regulations (C.F.R.).

- 2. Under 40 C.F.R. § 82.152, the following definitions apply:
 - "Appliance" means "any device which contains and uses a refrigerant and which
 is used for household or commercial purposes, including any air conditioner,
 refrigerator, chiller, or freezer.
 - "High-pressure appliance" means an "appliance that uses a refrigerant with a liquid phase saturation pressure between 170 psia and 355 psia at 104 °F. This definition includes but is not limited to appliances using R-404A, R-409A, R-401B, R-411A, R-22, R-411B, R-502, R-402B, R-408A, and R-402A."
- 3. Pursuant to 40 C.F.R. § 82.161(a)(2), technicians who maintain, service, or repair medium-, high-, or very high-pressure appliances, or dispose of medium-, high-, or very high-pressure appliances must be properly certified as Type II technicians.
- 4. Pursuant to Section 302(e) of the CAA, 42 U.S.C. § 7602(e), the term "person" includes, in relevant part, "an individual, corporation, or partnership." Respondent is a "person" as defined by Section 302(e) of the CAA, 42 U.S.C. § 7602(e), and thus subject to regulation.

FINDINGS OF VIOLATION

- 5. On November 1, 2008, the EPA issued an Information Request to Respondent,

 AAA Heating & Sheet Metal, Inc, requesting information to determine Respondent's compliance
 with regulations of the CAA regarding "Stratospheric Ozone Protection".
- 6. On November 25, 2008, the EPA received Respondent's Information Request Response. The submitted documentation was reviewed by the EPA enforcement staff, and determined that on September 19, 2008 Respondent failed to meet technician certification

requirements of 40 C.F.R. Section 82.161(a)(2) by allowing a Type I certified technician to service a high pressure appliance containing a class II controlled substance (R-22).

CONSENT AGREEMENT

- 8. Respondent admits the jurisdictional allegations and neither admits nor denies the factual allegations stated above.
- 9. Respondent waives his/her right to a hearing before any tribunal, to contest any issue of law or fact set forth in this Complaint and Consent Agreement.
- Order, applies to and is binding upon EPA and upon Respondent and Respondent's heirs, successors and assigns. Any change in ownership or corporate status of Respondent, including, but not limited to, any transfer of assets or real or personal property, shall not alter Respondent's responsibilities under this agreement. This Complaint and Consent Agreement contains all terms of the settlement agreed to by the parties.
- Section 113(d)(1)(B) of the CAA, 42 U.S.C. § 7413(d)(1)(B), and 40 C.F.R. Part 19 authorize the assessment of a civil penalty of up to \$32,500 per day of violation for each violation of the implementing regulations associated with the "Stratospheric Ozone Protection" requirements of Subchapter VI, section 608 of the CAA, 42 U.S.C. § 7671g. For purposes of determining the amount of any civil penalty to be assessed, Section 113(e)(1) of the CAA, 42 U.S.C. § 7413(e)(1), requires EPA to take into account, in addition to such other factors as justice may require, the size of the business, the economic impact of the penalty on the business, the violator's full compliance history and good faith efforts to comply, the duration of the violation as established by any credible evidence (including evidence other than the applicable

test method), payment by the violator of penalties previously assessed for the same violation, the economic benefit of noncompliance, and the seriousness of the violation.

- 12. Based on the factors listed in paragraph 11, and Respondent's acknowledgement that it is in full compliance with the requirements of the CAA, EPA has determined that an appropriate civil penalty to settle this action is **Two Hundred Seventy-Three Dollars (\$273)**.
- 13. Respondent consents, for the purpose of settlement, to the issuance of a final consent order in this matter and agrees to pay the civil penalty cited in the foregoing paragraph as follows:
 - a. Payment is to be made of **TWO HUNDRED AND SEVENTY-THREE DOLLARS (\$273)** due within 30 calendar days from the date written on a Final

 Consent Order, issued by the Regional Judicial Officer, which adopts this

 Complaint and Consent Agreement. If the due date falls on a weekend or legal

 Federal holiday, the due date is the next business day. Payments must be received by 11:00 a.m. Eastern Standard Time to be considered as received that day.
 - b. The payment shall be made by remitting a cashier's or certified check, including the name and docket number of this case, for the amount, payable to "Treasurer, United States of America," (or be paid by one of the other methods listed below) and sent as follows:

- c. In the event payment is not received by the specified due date, interest accrues from the date of the final consent order, not the due date, at a rate established by the Secretary of the Treasury pursuant to 31 U.S.C. § 3717, and will continue to accrue until payment in full is received. (That is, on the 1st late day, 30 days of interest accrues.)
- d. In addition, a handling charge of fifteen dollars (\$15) shall be assessed the 61st day from the date of the final consent order, and each subsequent thirty-day period that the debt, or any portion thereof, remains unpaid. In addition, a six percent (6%) per annum penalty shall be assessed on any unpaid principal amount if payment is not received within 90 days of the due date (that is, the 121st day from the date the final consent order is signed). Payments are first applied to handling charges, 6% penalty interest, and late interest; then any balance is applied to the outstanding principal amount.
- e. Respondent agrees that the penalty shall never be claimed as a federal or other tax deduction or credit.
- 14. Nothing in this Complaint and Consent Agreement shall relieve Respondent of the duty to comply with the CAA and its implementing regulations.

- Agreement shall constitute a breach of the consent agreement and may result in referral of the matter to the Department of Justice for enforcement of this agreement and such other relief as may be appropriate.
- 16. Nothing in this Complaint and Consent Agreement shall be construed as a waiver by the EPA or any other federal entity of its authority to seek costs or any appropriate penalty associated with any collection action instituted as a result of Respondent's failure to perform pursuant to the terms of this Complaint and Consent Agreement.
- 17. If the undersigned is a representative of the Respondent, he/she certifies that he/she is fully authorized to enter into the terms and conditions of this Complaint and Consent Agreement and to bind the parties he/she represents to the terms and conditions of this Complaint and Consent Agreement.
- 18. The parties agree to submit this Complaint and Consent Agreement to the Regional Judicial Officer, with a request that it be incorporated into a final consent order.
- 19. Each party shall bear its own costs and attorney fees in connection with this matter.
- 20. This Complaint and Consent Agreement, upon incorporation into a final consent order by the Regional Judicial Officer and full satisfaction by the parties, shall be a complete and full civil settlement of the specific violations alleged in the complaint portion of this Complaint and Consent Agreement.
