**EXPEDITED SETTLEMENT AGREEMENT**

**for violating monitoring, reporting, and/or recordkeeping (MRR) requirements in  
40 C.F.R. Part 61, Subpart M (National Emission Standard for Asbestos) and Section 112  
of the Clean Air Act.**

This Expedited Settlement Agreement (ESA) is being entered into by the United States Environmental Protection Agency, Region 4, Director of the Enforcement and Compliance Assurance Division (Complainant), and by W. T. MILLER, LLC (Respondent), pursuant to Section 113(d) of the Clean Air Act (the "Act"), 42 U.S.C. § 7413(d), and pursuant to 40 C.F.R. §§ 22.13(b) and 22.18(b)(2).

ALLEGED VIOLATIONS

Based on information received in response to an information request letter the EPA sent via electronic mail on January 28, 2021, to Respondent, the asbestos abatement and demolition contractor, the EPA alleges that Respondent violated Section 112 of the CAA, 42 U.S.C. § 7412, and 40 C.F.R. Part 61, Subpart M. Specifically, the EPA alleges the Respondent failed to conduct a thorough inspection of a commercial building located at 7505 River Road in Columbus, Georgia, 31904 (the "Facility") for asbestos-containing materials prior to beginning demolition activity, as required by 40 C.F.R. § 61.145(a). The EPA also alleges the Respondent failed to notify the Georgia Environmental Protection Division (EPD) at least 10 working days prior to beginning the demolition activity, as required by 40 C.F.R. § 61.145(b), at the Facility. Demolition activity occurred at the Facility from approximately December 2, 2020, through December 11, 2020.

SETTLEMENT

In consideration of Respondent's size, its full compliance history, its good faith efforts to comply, and other factors as justice may require, and upon consideration of the entire record, the parties enter into this ESA in order to settle the violations alleged above, for the total penalty amount of **\$5,474**.

This settlement is subject to the following terms and conditions: the Respondent by signing below admits the jurisdictional allegations contained herein, neither admits nor denies the specific factual allegations contained herein, and consents to the assessment of the penalty as stated above; Respondent waives its rights to a hearing afforded by Section 113(d)(2)(A) of the

Act, 42 U.S.C. § 7413(d)(2)(A), and to appeal this ESA and Final Order or otherwise contest the allegations contained in this ESA; and each party to this action shall bear its own costs and fees, if any.

Respondent certifies, subject to civil and criminal penalties for making a false submission to the United States Government, that the Respondent is currently in compliance with the National Emission Standard for Asbestos regulations promulgated at 40 C.F.R. Part 61, Subpart M. Within fifteen (15) days of receiving a copy of the fully executed ESA, Respondent shall pay a civil penalty in the amount of **\$5,474**. Respondent's payment shall be made by sending a cashier's check or certified check (payable to the "Treasurer, United States of America") in the amount of **\$5,474** in payment of the full penalty amount to one of the following addresses or via wire transfer:

Respondent's full compliance with this ESA shall only resolve Respondent's liability for Federal civil penalties for the violations alleged in this ESA. The EPA does not waive any other enforcement action for any other violations of the Act or any other statute.

This ESA is binding on the parties signing below. This ESA is effective upon filing with the Regional Hearing Clerk.

In accordance with 40 C.F.R. § 22.5, the individuals named in the certificate of service are authorized to receive service related to this proceeding and the parties agree to receive service by electronic means.
