- 1. In addition to the COMBINED COMPLAINT AND CONSENT AGREEMENT ("CCCA") filed in this matter, the Complainant submits the following factual basis in support of the violations alleged in the Complaint portion of the CCCA.
 - a. On January 16, 2008, an authorized representative of EPA conducted a Residential Lead-Based Paint Hazard Reduction Act ("Residential Lead Hazard Act") and the Toxic Substances Control Act ("TSCA") compliance review for the Jerry Street Apartments located at 319 and 321 Jerry Street, Castle Rock, Colorado. During the compliance review and subsequent case review, EPA observed that the Jerry Street Apartments had violated regulations implementing the Residential Lead Hazard Act and TSCA. These observed violations are set out in detail in Paragraph 4 in the CCCA.

COMPLAINT

GENERAL ALLEGATIONS

- 1. This civil administrative enforcement action is authorized by Congress in the Residential Lead-Based Paint Hazard Reduction Act ("Residential Lead Hazard Act") and the Toxic Substances Control Act ("TSCA"). 42 U.S.C. § 4851 et seq, and 15 U.S.C. § 2601 et seq. EPA regulations authorized by the statutes are set out in part 745, subpart F of title 40 of the Code of Federal Regulations ("C.F.R.") and, as set out in 42 U.S.C. § 4852d (b)(5), violations of the regulations constitute violations of section 16 of TSCA. This proceeding is subject to EPA's "Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation or Suspension of Permits, ("Rules of Practice"), 40 C.F.R. part 22, and this COMPLAINT AND CONSENT AGREEMENT ("simultaneous combined action") is authorized by the rules. 40 C.F.R. § 22.13(b). The undersigned EPA officials have been properly delegated the authority to issue this action. These general allegations apply to each count below.
- 2. Respondent is Jack Christensen, ("Respondent"). Respondent is, and at all times relevant to this simultaneous combined action has been, the owner or co-owner, as that term is defined in 40 C.F.R. § 745.103, of Jerry Street Apartments property located at 319 and 321 Jerry Street, Castle Rock, CO 80104, which is "residential real property" within the meaning of §1004(24) of the Residential Lead Hazard Act, 42 U.S.C. § 4851b(24), and was constructed before 1978.
- 3. EPA regulations require, among other things, that an owner of housing constructed before 1978 shall, prior to obligating a lessee under a contract to lease or rent the housing, provide or include in or attach to the leasing contract, (1) an EPA-approved lead hazard information pamphlet, (2) a lead warning statement, (3) a statement disclosing the presence of any known

lead-based paint and/or lead-based paint hazards (or lack of knowledge of such presence), (4) a list of any records or reports available to the owner related to lead-based paint or hazards (or a statement that no such records exist), (5) a statement by the renter/lessee that he/she received the above information, and (6) signatures (dated) by both parties certifying the accuracy of their statements. 40 C.F.R. §§ 745.107(a)(1) and 745.113(b).

VIOLATIONS

- 4. As an owner or manager of residential real property, Respondent has failed to comply with the following requirements:
 - a. Respondent failed to provide an EPA-approved lead hazard information pamphlet prior to entering into lease contracts in violation of 40 C.F.R. § 745.107(a) (1), 42 U.S.C. § 4852d(b)(5), 15 U.S.C. § 2689.
 - b. Respondent failed to include a lead warning statement within the lease contracts before the renters/lessees are obligated or enter into a lease contract in violation of 40 C.F.R. § 745.113(b)(1), 42 U.S.C. § 4852d(b)(5), 15 U.S.C. § 2689.
 - c. Respondent failed to include a statement disclosing the presence of any known lead-based paint and/or lead-based paint hazards (or lack of knowledge of such presence), within the lease contracts before the renters/lessees are obligated or enter into a lease contract in violation of 40 C.F.R. § 745.113(b)(2), 42 U.S.C. § 4852d(b)(5), 15 U.S.C. § 2689.
 - d. Respondent failed to include a list of any records or reports available to the owner related to lead-based paint or hazards (or a statement that no such records exist) within lease contracts before the renters/lessees are obligated or enter into a lease contract in violation of 40 C.F.R. § 745.113(b)(3), 42 U.S.C. § 4852d(b)(5), 15 U.S.C. § 2689.
 - e. Respondent failed to include a statement by the renters/lessees that the renters/lessees received the information described above in violation 40 C.F.R. § 745.113(b)(4), 42 U.S.C. § 4852d(b)(5), 15 U.S.C. § 2689.
 - f. Respondent failed to include the signature of the lessor and lessee certifying to the accuracy of their statements, to the best of their knowledge along with the dates of signature, in violation 40 C.F.R. § 745.113(b)(6), 42 U.S.C. § 4852d(b)(5), 15 U.S.C. § 2689.

CONSENT AGREEMENT

- 5. Respondent admits the jurisdictional allegations and neither admits nor denies the factual allegations stated above.
- 6. Respondent waives its right to a hearing before any tribunal, to contest any issue of law or fact set forth in this Complaint and Consent Agreement.
- 7. This Complaint and Consent Agreement, upon incorporation into a Final Consent Order, applies to and is binding upon EPA and upon Respondent and Respondent's heirs, successors and assigns. Any change in ownership or corporate status of Respondent, including, but not limited to, any transfer of assets or real or personal property, shall not alter Respondent's responsibilities under this agreement. This Complaint and Consent Agreement contains all terms of the settlement agreed to by the parties.
- 8. Section 16 of TSCA, 15 U.S.C. § 2615, and the regulations promulgated under section 6 of TSCA, 15 U.S.C. § 2605, as amended, authorize the assessment of a civil penalty of up to \$32,500 per day of violation for each violation of TSCA except for violations of the Lead-Based Paint Hazard Reduction Act which shall not exceed \$11,000 per violation. In arriving at the amount of the penalty, EPA, as required by section 16(a)(2)(B) of TSCA, 15 U.S.C. § 2615(a)(2)(b), has taken into consideration, to the extent known at this time, the nature, circumstances, extent, and gravity of the violation, and, with respect to respondents, the ability to pay, effect on ability to continue to do business, any history of prior violations, degree of culpability, and other matters as justice may require. Respondents have demonstrated that they are in compliance with applicable provisions of the Residential Lead Hazard Act. Respondents consent and agree to pay a civil penalty in the amount of TWO HUNDRED AND FIFTY DOLLARS (\$250), in the manner described below in the following subparagraphs:
 - a. Payment is to be made in two installments of ONE HUNDRED TWENTY FIVE DOLLARS (\$125) per installment, and the first installment is due within 30 calendar days from the date written on a Final Consent Order, issued by the Regional Judicial Officer, which adopts this Complaint and Consent Agreement. If the due date falls on a weekend or legal Federal holiday, the due date is the next business day. Payments must be received by 11:00 a.m. Eastern Standard Time to be considered as received that day. The second installment of ONE HUNDRED TWENTY FIVE DOLLARS (\$125) is due within 60 calendar days from the date written on a Final Consent Order, issued by the Regional Judicial Officer, which adopts this Complaint and Consent Agreement
 - b. Each payment shall be made by remitting a cashier's or certified check, including the name and docket number of this case, for the amount, payable to

- c. In the event payment is not received by the specified due date, interest accrues from the date of the final consent order, not the due date, at a rate established by the Secretary of the Treasury pursuant to 31 U.S.C. § 3717, and will continue to accrue until payment in full is received. (That is, on the 1st late day, 30 days of interest accrues).
- d. In addition, a handling charge of fifteen dollars (\$15) shall be assessed the 61st day from the date of the final consent order, and each subsequent thirty-day period that the debt, or any portion thereof, remains unpaid. In addition, a six percent (6%) per annum penalty shall be assessed on any unpaid principal amount if payment is not received within 90 days of the due date (that is, the 121st day from the date the final consent order is signed). Payments are first applied to handling charges, 6% penalty interest, and late interest; then any balance is applied to the outstanding principal amount.
- Respondent agrees that the penalty shall never be claimed as a federal or other tax deduction or credit.

- 9. Nothing in this Complaint and Consent Agreement shall relieve Respondent of the duty to comply with TSCA and its implementing regulations.
- 10. Failure by Respondent to comply with any term of this Complaint and Consent Agreement shall constitute a breach of the consent agreement and may result in referral of the matter to the Department of Justice for enforcement of this agreement and such other relief as may be appropriate.
- 11. Nothing in this Complaint and Consent Agreement shall be construed as a waiver by the EPA or any other federal entity of its authority to seek costs or any appropriate penalty associated with any collection action instituted as a result of Respondent's failure to perform pursuant to the terms of this consent Agreement.
- 12. If the undersigned is a representative of the Respondent, he/she certifies that he/she is fully authorized to enter into the terms and conditions of this Complaint and Consent Agreement and to bind the parties he/she represents to the terms and conditions of this Complaint and Consent Agreement.
- 13. The parties agree to submit this Complaint and Consent Agreement to the Regional Judicial Officer, with a request that it be incorporated into a final consent order.
- 14. Each party shall bear its own costs and attorney fees in connection with this matter.
- 15. This Complaint and Consent Agreement, upon incorporation into a final consent order by the Regional Judicial Officer and full satisfaction by the parties, shall be a complete and full civil settlement of the specific violations alleged in the complaint portion of this Complaint and Consent Agreement.
