ORDER GRANTING MOTION FOR EXTENSION OF TIME

By Motion dated June 10, 2010, the parties jointly moved for another extension of time to file the Consent Agreement and Final Order.

The Motion is hereby, **GRANTED**, as set forth below:

Section 22.7(b) of the Rules of Practice (40 C.F.R. § 22.7(b)) provides that the Presiding Officer may grant an extension of time for filing any document upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties.

Good cause exists for the granting of the Motion in that it is in the interest of the parties and judicial economy for the parties to settle this matter on mutually agreeable terms rather than litigate the matter to conclusion. The Motion indicates that the parties' Consent Agreement has been executed by the Respondent and is awaiting final signature by the Agency before filing. In that a hearing in this case has yet to be scheduled, no prejudice will result from a brief delay. Therefore, the parties shall have until **JUNE 18, 2010** to file the fully executed Consent Agreement and Final Order.


