Dear Mr. Eisel:

This letter is in response to your submission of the "S.E.P. Completion Report" to the U.S. Environmental Protection Agency (EPA) as required by paragraph 96 of the above-referenced Consent Agreement and Final Order (CAFO). After reviewing your report, the EPA has determined that the supplemental environmental projects (SEPs) listed in the CAFO (and as modified through subsequent agreement), have been satisfactorily completed and that there are no deficiencies in any of the SEPs or in your report. The EPA congratulates Hicksville Grain Company on its efforts to successfully complete these SEPs. Your report also included a "S.E.P. Expense Data" page which calculated that Hicksville Grain Company owes the EPA is \$8,273 as a stipulated penalty. However, for the reasons explained below, the EPA is demanding, through this letter, that Hicksville Grain Company pay a stipulated penalty of only \$7,180.

Paragraph 82 of the CAFO specified that "U.S. EPA has determined that an appropriate civil penalty to settle this action is \$27,000." However, pursuant to paragraph 83 of the CAFO, Hicksville Grain Company had the option of either paying the \$27,500 civil penalty or completing "the supplemental environmental projects as detailed in paragraphs 89 to 107." Paragraphs 89 and 90 of the CAFO listed four SEPs which Hicksville Grain Company could complete in lieu of paying the \$27,500 civil penalty; and paragraph 91 specified that Hicksville Grain Company's expenditures for those four SEPs must total at least \$26,407 (\$5,637 + 7,250 + 9,760 + 3,760) to avoid paying a stipulated penalty.

Paragraph 101(a) of the CAFO states that if Hicksville Grain Company spends "less than the amount set forth in paragraph 91, [then Hicksville Grain Company] must pay a stipulated penalty equal to the difference between the amount it spent on the SEP and the amount set forth in paragraph 91." Therefore, since Hicksville Grain Company spent \$19,227 on the four SEPs, the EPA is demanding \$7,180 in stipulated penalties (\$26,407 minus \$19,227), not \$8,273.

Finally, paragraph 103 of the CAFO states that Hicksville Grain Company shall pay any stipulated penalties owed within fifteen (15) days of receiving a demand letter such as this, and that such payment will be made as specified in the CAFO. However, since the start of the federal government's new fiscal year on October 1, the EPA has new addresses for which to send penalty payments. Please disregard the addresses listed in paragraphs 83 and 85 of the CAFO, and send your payment to one of the addresses listed on the enclosed "Payment Addresses as of October 1, 2007."
