ORDER GRANTING MOTION TO MODIFY CONFERENCE DEADLINES

A Prehearing Order was issued in this matter directing the parties, *inter alia*, to engage in a settlement conference on or before January 20, 2010 and directing Complainant to file a status report regarding settlement on or before January 25, 2010. Complainant submitted on January 13, 2010 a Motion to Modify Conference Deadlines, requesting that these directives be vacated and that the deadlines be extended by seven days.

The Motion states that the parties agreed to hold a settlement conference on January 26, 2010 and were unable to find a mutually convenient date prior to that time. The Motion states further that Respondent's counsel indicated his assent to the extension sought.

The Motion is hereby **GRANTED**. Good cause exists for the granting of the Motion in that it is in the interest of the parties and judicial economy for the parties to settle this matter on mutually agreeable terms rather than litigate the matter to conclusion. In that a hearing in this case has not been scheduled, no prejudice will result from a brief delay. Accordingly, the parties are directed to engage in a settlement conference on or before **January 27, 2010**, and attempt to reach an amicable resolution of this matter. The Complainant shall file a status report regarding the progress of settlement efforts on or before **February 1, 2010**.




