

**COMPLAINANT'S STATUS REPORT ON MEDIATION**

Pursuant to the terms of Chief Administrative Law Judge Biro's September 29, 2009 prehearing order granting a stay for mediation in the above matter, the complainant submits the following report on the status of that mediation. The parties have selected a neutral mediator, Robert Fisher, of Fisher Collaborative Services LC, and conducted an initial telephone conference on Monday, October 19, 2009, at which the parties discussed expectations, scheduling, mediation statements, and other process considerations. The mediator will provide the parties with guidance on the preparation of mediation statements and the parties will provide those statements to the mediator within a week of receiving the guidance. Shortly thereafter, the mediator will speak with each party separately, and then the parties will participate in a second conference call on Monday, November 9, 2009, to attempt to resolve this matter.
