Dear County Commissioners:

The Safe Drinking Water Act (SDWA) requires that the United States Environmental Protection Agency (EPA) notify locally elected officials of certain enforcement actions taken in their area.

An Administrative Order is being issued to The Sinclair Companies, owner and/or operator of the Sinclair Refinery Golf Course water system, located in Sinclair, Wyoming. This Order requires that The Sinclair Companies take measures to return its public water system to compliance with the SDWA and the National Primary Drinking Water Regulations (NPDWRs). These violations include: failing to monitor for turbidity, and failing to maintain a residual disinfectant level above 0.2 milligrams per liter (mg/L).

To Whom It May Concern:

Enclosed is an Administrative Order (Order) issued by the Environmental Protection Agency (EPA) under the authority of the Safe Drinking Water Act, 42 U.S.C. §§ 300f et seq. Among other things, the Order alleges that The Sinclair Companies (Sinclair) has violated the National Primary Drinking Water Regulations (the drinking water regulations).

The Order is effective upon the date received. Please review the Order and within 10 days provide EPA with any information you believe EPA may not have. If Sinclair complies with the Order, EPA may close the Order without further action. Failure to comply with the Order may lead to substantial civil penalties and/or a Federal court injunction ordering compliance.

- 1. This Order is issued under the authority vested in the Administrator of the United States Environmental Protection Agency (EPA) by the Safe Drinking Water Act, 42 U.S.C. §§ 300f et seq. (the Act), as properly delegated to the undersigned officials.
- 2. The Sinclair Companies (Respondent) is a Wyoming corporation that owns and/or operates the Sinclair Refinery Golf Course Water System (the system), which provides piped water to the public in Carbon County, Wyoming, for human consumption.
- 3. The system is supplied by a surface water source (the North Platte River), which is treated by coagulation, flocculation, chlorination, sedimentation, and filtration. Although the system has two parallel filtration systems (bag filtration, and membrane filtration), only the membrane filtration system is used for compliance with the Long-Term 2 Enhanced Surface Water Treatment Rule (LT2SWTR) during the operating season of the golf course.
- 4. The system has approximately 10 service connections and/or regularly serves at least 130 individuals daily at least 60 days out of the year. Therefore, the system is a "public water system" as defined in § 1401(4) of the Act, 42 U.S.C. § 300f (4), and 40 C.F.R. § 141.2. The system is also a "transient, non-community water system" as defined in 40 C.F.R. § 141.2.
- 5. Respondent is subject to the Act and the National Primary Drinking Water Regulations (drinking water regulations) at 40 C.F.R. part 141. The drinking water regulations are "applicable requirements" as defined in § 1414(i) of the Act, 42 U.S.C. § 300g-3(i).

VIOLATIONS

- 6. Respondent is required to monitor the system's filtered water for turbidity by monitoring representative samples of the filtered water at least once every 4 hours that the system serves water to the public. 40 C.F.R. § 141.74(c)(1). Respondent failed to monitor the system's water for turbidity every 4 hours on June 9, 10, 12, and 13, 2009, and, therefore, violated this requirement.
- 7. Respondent is required to maintain a residual disinfectant level in the water entering the system's distribution system. This level may not be less than 0.2 milligrams per liter (mg/l) for any period of more than 4 hours. 40 C.F.R. § 141.72(b)(2). On May 28, 30, and 31, 2009, the disinfectant level in the system was less than 0.2 mg/l for 4 hours or longer. Therefore, Respondent violated this requirement.

ORDER

Based on the above violations, Respondent is ordered to perform the following actions upon Respondent's receipt of this Order (unless a different deadline is specified below):

- 8. At least once every 4 hours that the system provides water to the public, Respondent shall monitor the system's filtered water for turbidity as required by 40 C.F.R. § 141.74(c)(1). Respondent shall report results to the EPA within 10 days following the end of the monitoring period as required by 40 C.F.R. § 141.75.
- 9. Respondent shall ensure that the residual disinfectant concentration in water entering the system's distribution system be at least 0.2 mg/l for every 4-hour period, as required by 40 C.F.R. § 141.72.
- 10. Respondent shall direct all reporting required by this Order to:

GENERAL PROVISIONS

- 11. This Order does not constitute a waiver, suspension, or modification of any requirement of the Act or drinking water regulations. Issuance of this Order is not an election by EPA to forgo any civil or criminal action.
- 12. Violation of any part of this Order or the drinking water regulations may subject Respondent to a civil penalty of up to \$37,500 (as adjusted for inflation) per day of violation. 42 U.S.C. § 300g-3; 40 C.F.R. part 19.
