

**REPORT OF STATUS CONFERENCE AND ORDER**

**Introduction:** The Presiding Officer established that the purpose of the teleconference was to assess the status of this matter.

**Status:** The Respondents' and Complainant's attorneys had submitted a Joint Motion for a Stay of the Proceedings dated July 27, 2011, together with a draft Order. The Order, which was signed by the Undersigned earlier on the morning of August 2nd, provided for a nine month stay of these proceedings and required that the Parties submit a joint status report no later than March 22, 2012.

However, during the conference, the Undersigned indicated it would be preferable for the parties to participate in a status teleconference during the nine month period of the requested stay, and the parties agreed that they would be available on November 8, 2011 to participate in a status teleconference.
