Enclosed is an Administrative Order to Compel Compliance with Information Request ("Order") that requires you to provide information to the United States Environmental Protection Agency ("EPA") regarding your connection to Standard Metals Corporation, the current owner of the Standard Mine Superfund Site, in Gunnison County, Colorado.

EPA sent you a letter ("Information Request Letter") on or about August 8, 2007, requesting information. The return receipt indicates that you received this Information Request Letter on August 11, 2007. Your response was due on or before September 10, 2007. Andrea Madigan, the EPA attorney for this matter, received several phone calls from your son and your attorney, Stuart Reed, regarding the Information Request Letter and was told that the requested information would be provided. On or about November 20, 2007, EPA sent you another letter with a copy to your legal counsel, again advising you of your obligation to promptly submit a response to the Information Request Letter. To date, EPA has not received any response.

Your compliance with the enclosed Order is required by law. Section 104 of Comprehensive Environmental Response, Compensation, and Liability Act, 42 U.S.C. Section 9604, authorizes EPA to pursue penalties of up to \$32,500 per day for failure to timely respond. In addition, providing false, fictitious or fraudulent statements or representations may subject you to criminal penalties under 18 U.S.C. Section 1001.

Please note that in accordance with Paragraph 24, you may request a conference within three business days after your receipt of this Order to deal with any matter pertinent to this Order. You may also submit written comments or statements of position on any matter pertinent to this Order no later than the time of the conference or no later than two days before the effective date

of the Order if you do not request a conference. EPA will deem you to have waived your right to a conference or to submit written comments if you fail to request the conference or to submit written comments, within the specified time period.
