
This letter is an addendum to the Administrative Order (Order) issued on January 22, 2015, to Encore Energy Partners Operating LLC (Encore). The purpose of this letter is to approve the April 17, 2015, schedule submitted by GDA Engineers on behalf of Encore, for coming into compliance with the Long Term 2 Enhanced Surface Water Treatment Rule (LT2 ESWTR) by installing and operating treatment that provides the maximum required *Cryptosporidium* treatment (5.5 logs total *Cryptosporidium* reduction). The schedule is hereby incorporated into the Order per paragraph 8 (page 2) of the Order.

Order UV treatment system	September 18, 2015
Installation	September 21, 2015 - October 15, 2015
Certification	November 13, 2015

Pursuant to paragraph 11 of the Order, the Encore shall achieve compliance with the LT2 ESWTR by the final compliance deadline in this approved schedule, December 25, 2015. The EPA is authorized to seek penalties if these deadlines are not met. If Encore has a reasonable basis to believe it may be unable to meet any deadline in the schedule, it shall notify the EPA well in advance of the scheduled deadline to request an extension. The EPA may, in its discretion, consider granting an extension.
