MOTION TO EXTEND ALTERNATIVE
DISPUTE RESOLUTION

The Complainant, the United States Environmental Protection Agency (EPA), Region 7, by and through its attorney, respectfully requests an extension of time for the Alternative Dispute Resolution Process, based on the reasons specified below:

1. The parties have reached agreement in principle concerning injunctive relief in settlement of this matter.
2. Respondent has presented several Supplemental Environmental Projects (SEPs) that may be a component of settlement of this matter.
3. Following consultation with Respondent's facility and members of the surrounding community, Respondent will draft one or more SEP proposals for consideration by Complainant.

4. Pursuant to EPA's Supplemental Environmental Projects Policy, the SEP proposals will require approval from the appropriate officials in EPA Headquarters.


5. It is in the best interest of the parties to continue negotiations, as the parties believe that settlement of this matter will include performance of one or more SEPs, and additional time is necessary to incorporate the SEPs into a Consent Agreement and Final Order.

6. Counsel for Complainant is advised that Respondent has no objection to this extension.

Therefore, Complainant respectfully requests that this Motion be granted allowing Alternative Dispute Resolution to continue for an additional thirty days from February 12, 2010.
