Counsels for Complainant and for Respondents have had several conversations about the legal positions of their respective clients.

Counsel for Complainant sent a detailed financial information form for Respondent Mr. LaCroix to complete and return. Counsel for Respondents has indicated that Mr. LaCroix is preparing a response to the form and will submit it to the Complainant soon.

Counsel for Respondents indicates that the Respondents have arranged to meet on September 24, 2007, with representatives of the Minnesota Pollution Control Agency (MPCA) to discuss the requirements of a RCRA closure plan for the facility operated by the Respondents.
