

REPORT RECOMMENDING CONTINUATION  
OF ALTERNATIVE DISPUTE RESOLUTION PROCESS

The Chief Administrative Law Judge's Order of August 27, 2013 provides that this alternative dispute resolution (ADR) process terminates October 28, 2013. The recommendation of this Report is that the ADR process be continued to December 13, 2013.<sup>1</sup>

This continuation of the ADR process is recommended because the parties' negotiations are ongoing. In a request for extension of ADR dated October 28, 2013, the parties agreed to an extension of the ADR process.
