July 6, 2009. In addition, Attorney Soto advised the undersigned that Respondent

would seek an extension to file an Amended Answer to the Complaint, to which

Complainant would not object, should this Honorable Court decide to grant such

extension.

5. As soon as Respondent submits the NOI form, the undersigned will propose a

meeting to further explore settlement options that were brought to Attorney Soto's

attention during the conference call.

6. Complainant was granted until July 6, 2009 to file a status report regarding such

settlement conference(s).

WHEREFORE it is respectfully requested that the Court take notice of the status

of the instant case.
